COUNCILMEMBER COMMENTS AND MEETING ATTENDANCE REPORTS:

Councilmember Heilman thanked everyone who voted and participated in the recent election. He provided comments on Item 2.N., specifically the design of the Sunset Shuttle and indicated that the design return to Council for consideration and deliberation. He thanked everyone who spoke on Item 5.A. He states that although he did not support the Arts Club project due to its large size, he does not agree that this should have gone through the referendum process. He responded to some of the comments expressed during Public Comment regarding the City's efforts as it relates to affordable housing and restated the Council's commitment. He reported that he attended the National League of Cities Annual Conference in Los Angeles. He wished everyone a Happy Thanksgiving.

Councilmember Meister spoke regarding Item 2.F. and congratulated the Transportation Commission. She thanked Councilmember Heilman for bringing forward Item 2.P. She mentioned Item 2.R. and the fact that China reversed the decision but stated she would still like to move forward with the resolution. She spoke regarding Item 5.A. and supports placing the Item on the March 5, 2019 ballot. She clarified the aspects of the development and the public benefits associated with the project.

Councilmember Horvath thanked the first responders handling the wildfires, specifically the City's Public Safety Department for their assistance with the City of Malibu's EOC. She congratulated everyone who worked on campaigns for the November election. She specifically thanked Karen Eyres for her hard work in the campaigns. She reported that she attended the recent Clean Power Alliance board meeting. She reported that she attended the National League of Cities Conference in Los Angeles, where she participated in panel discussions with the City's Chamber representatives on conversations on Cannabis. She thanked Councilmember Heilman for his work on the Gay and Lesbian Bisexual caucus in West Hollywood. She thanked everyone who participated in the Veterans Day events. She congratulated WeHo Housing Corp on the opening of the Blue Hibiscus. She spoke regarding the opening of Councilmember Ryu's housing for women; which is located just outside West Hollywood. She thanked

everyone who participated in the recent NextGen event. Thanked the Chamber for the Creative City awards. She asked the City Attorney to clarify Item 5.C. and how the funding that will be used, as well as if this type of funding can be used for educating the residents regarding the Arts Club. She spoke regarding Item 5.A. and she clarified some of the misinformation surrounding the project. Finally, she mentioned that Southern California Edison severely under-charged their users and that the Clean Power Alliance is working on this issue. She requested that an item be placed on the next City Council agenda to discuss this issue.

Mayor Duran spoke regarding Item 2.B., the minutes from the November 5, 2019 meeting; and requested that they be corrected to show that on Item 4.B., it was he and Councilmember Meister who voted No on the item and not Mayor Pro Tempore D'Amico. He spoke regarding the upcoming Transgender Day of Remembrance at the Jeremy Hotel at 6:00 November 20th. He spoke regarding the upcoming Toy Box party on Sunday that benefits children who are impacted by HIV/AIDS. He spoke regarding assistance from City staff to the City of Malibu and the EOC in Santa Monica and thanked them for their hard work. Finally, he mentioned World AIDS Day and the events scheduled to commemorate it, and introduced a video from the Social Services Division.

CITY MANAGER'S REPORT:

City Attorney Jenkins responded to Councilmember Horvath's inquiry on expending City funds to educate the public on a Cannabis tax. He clarified the difference between campaign materials and educational materials.

City Manager Arevalo spoke regarding the Westside cities emergency response to the assist the City of Malibu and thanked Public Safety Director Kristin Cook for her efforts. He reported on the affordable units at 8500 Sunset Boulevard. He mentioned that City Hall will be closed Thursday and Friday for Thanksgiving and provided the various holiday parking changes throughout the City. He wished everyone a Happy Thanksgiving.
