V. New Business

A. NCJW/LA Annual Roe v. Wade Commemoration

The Board discussed their participation and support of the annual Roe v. Wade event sponsored by the National Council of Jewish Women/Los Angeles in conjunction with a coalition of organizations, which commemorates the anniversary of the landmark Supreme Court decision legalizing abortion in the United States.

The event will be held on Wednesday, January 23, 2019 at NCJW/LA.Board Member Eyres and Board Member Bleich have been attending the NCJW/LA planning meetings. Board Member Lubey volunteer to assist at the event as well.

ACTION: Co-Sponsorship of NCJW/LA's annual Roe V. Wade Commemoration in 2019, motioned by Board Member Moore, seconded by Board Member Deal, and approved unanimously.

B. Local Implementation of the United Nations Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW)

Staff gave a brief presentation about the Convention on the Elimination of All Forms of Discrimination against Women (**CEDAW**), an international bill of rights for women adopted in 1979 by the UN General Assembly, and the efforts of local cities to implement it locally in their jurisdictions. Brief update regarding the status of the City's efforts to implement CEDAW.

Strategic Initiatives Manager Corri Planck provided an update regarding the status of the City's Aging in Place Initiative. The City is part of a AARP-led California statewide group to discuss keeping seniors in place and recently City adopted policies to make the City an Alzheimer and dementia friendly city.

The Board received a brief presentation about domestic violence and victimization within the Family Court System. Advocates Roman James and Latia Suttle and spoke on their personal experiences with the family court system and reported on statistics about domestic violence in both California and the nation and how the court system has been used as a means to perpetuate domestic violence against women and children. It was recommended that the Board watch a documentary "What Doesn't Kill Me" to learn more about domestic violence and advocacy around the issue.
