NOEMI TORRES, West Hollywood, spoke about the short film called *Tijuana* by a local woman filmmaker who is seeking a screening opportunities. She encouraged the Board to watch the film online.

5. New Business

A. West Hollywood Planned Parenthood Action League

Kat Keene, shared information about advocacy and leadership opportunities with the West Hollywood Planned Parenthood Action League, and PPAL's in general, which are hyper-local volunteer groups that focus on outreach, advocacy and grassroots efforts to protect their local Planned Parenthood Los Angeles health centers. Information regarding leadership opportunities and volunteer opportunities was shared.

A. She Angels Update

Catherine Gray, founder of 360Karma and producer of She Angels, a pitchfest funding competition for women entrepreneurs and web series co-sponsored by the Board, shared updates. The original plans have changed and there are now two events, the first on March 31, 2019 premiere the She Angels web series and a second event in in October 2019 to film the next pitchfest. The Board will discuss their participation at the upcoming event in March at a future meeting.

B. National Women's History Month Celebration 2019

The Board discussed planning for the City's annual commemoration of National Women's History Month held during the month of March.

Women's History Month Banners:
 Anita Hill and Dr Blasey Ford were nominated to be recognized on commemorative banners.

Board Member Romo reported back after speaking with the City's Arts Division Manager regarding the feasibility of creating an arts related activity and recommended utilizing the digital billboards on Sunset Blvd. It was suggested that messaging focus on the City's past Women's History Month and advocacy efforts. Boardmember Moore spoke about the possibility of the sculpture *Fearless Girl* might be available as an installation.

3. International Women's Day

The Board discussed their participation in the annual International Women's Day sponsored by the Russian Advisory Board on March 3rd. The Board discuss the feasibility of coordinating an advocacy-oriented event or activity about the history of International Women's Day. Board Member Eyres also suggested supporting UN's theme for International Women's Day which is #BalanceforBetter which is about balancing the amount of house and care work between women and men. It was suggested that sharing campaign information digitally might be feasible.

Boardmember Eyres reported that Hollywood chapter of the National
Organization for Women once again seeks the support of the Board to host
their annual awards ceremony which will honor Chela Demuir-Cartier,
President of the Unique Women's Coalition.

- 4) Approve a motion to request the purchase of the United Nations International Women's Day partner kit at the amount of \$200 and approve incorporating the theme of #BalanceforBetter in the Board's activities, motioned by Board Member Deal, Seconded by Board Member Eyres, and approved unanimously.
