## Item 6.A. Public Comment:

VICTOR OMELCZENKO, WEST HOLLYWOOD PRESERVATION ALLIANCE congratulated Staff, HPC and members of the preservation community on the proposed projects within the report. He commended the HPC concerning newly added Cultural Designations, proposed updates to Millis Act Contract and proposed goals for 2018/2019.

## 8. PUBLIC HEARINGS:

# A. 7156 SANTA MONICA BOULEVARD (FORMOSA CAFÉ) LOCAL CULTURAL RESOURCE DESIGNATION

HPC INTERN MIKE PETERSON gave a presentation detailing information as reflected in the January 28, 2019 staff report for the Commission-Initiated Cultural Resource Designation of 7156 Santa Monica Boulevard (Formosa Café).

He said Staff finds that the building possesses full integrity of location, setting, feeling and association as it is on its original site on Santa Monica Boulevard and across from the studio.

The building has lost integrity of design, materials and workmanship but maintains sufficient integrity of its character-defining features. He said the building qualifies for designation as a cultural resource under Criteria B - Example of Distinguishing Characteristics and Criteria C - Identified with Persons or Events.

He said Staff received documents after the item was published in support of the designation.

## Item 8.A. Commissioner Questions To Staff:

STAFF AND THE COMMISSON asked about property owner support of the nomination. They addressed concerns regarding the 800-Series Railway Cars, Recent removal of the display case and addition of a HVAC system at the top of the trolley.

HPC LIAISON JENNIFER ALKIRE said the display case was removed and HVAC system was added outside the scope of existing Certificates of

Appropriateness and is under review by the Planning and Code Compliance departments.

COMMISSIONER LAJOIE requested missing dates be added to the photos in the nomination application of the proposed project.

#### Item 8.A. Public Comment:

ROY OLDENKAMP, WEST HOLLYWOOD PRESERVATION ALLIANCE Commended former members of the Cultural Heritage Advisory Board, Preservation Historian Stacey Failing, the 1933 Group, the L.A. Conservancy, the National Trust and Staff for their efforts towards designating and preserving the historic elements of the café.

TRACY PATTIN, WEST HOLLYWOOD spoke in favor of Staff's recommendation. She thanked the Commission for their support of the designation.

ACTING HPC SECRETARY DANNY CASILLAS read into public record the following members of the public which completed citizen position slips in lieu of speaking: Susana Miller, Tod Hallman, Roxanne McBryde, Michael Haddad, Dave Monks and Victor Omelczenko.

## Item 8.A. Commissioner Comments:

COMMISSIONER LEVIN spoke in favor of the designation. He recommended the following changes to the resolution for designation:

- Include Criterion A Exemplifies Special Elements of the City for designation.
- Remove "The scale of the one-story building along Santa Monica Boulevard"
- Remove "(potentially) the curio cabinet at the back of the trolley".

COMMISSIONER CHARLIE spoke in favor of the nomination for designation and thanked Staff for report. He said he supports the recommended amendments by Commissioner Levin.

COMMISISONER OSTERGREN spoke in favor of the nomination for designation and recommended that language be added noting the significance of the building being one of the few examples of a trolley car incorporated into a cafe building. She said she supports amendments by Commissioner Levin.

COMMISSIONER BLAIVAS spoke in favor of Staff's recommendation. She said she supports the recommended amendments by Commissioner Levin and the nomination for designation.

COMMISSSIONER LAJOIE spoke in favor of Staff's recommendation. He said he supports the recommended amendments by Commissioner Levin.

MEMBERS OF THE COMMISSION AND STAFF discussed and recommended that Staff include language regarding the uncertainty of the display case at the rear of the trolley being original to the cafe.

COMMISSIONER LEVIN moved that Resolution No. HPC19-132, A RESOLUTION OF THE HISTORIC PRESERVATION COMMISSION OF THE CITY OF WEST HOLLYWOOD, RECOMMENDING THAT THE CITY COUNCIL DESIGNATE THE PROPERTY AT 7156 SANTA MONICA BOULEVARD, WEST HOLLYWOOD, CALIFORNIA AS A LOCAL CULTURAL RESOURCE (CRD 18-0002) be approved with the following amendments:

- Section 4 Include Criterion A Exemplifies Special Elements of the City for designation.
- Section 6 Remove "The scale of the one-story building along Santa Monica Boulevard"
- Section 6 Remove "(potentially) the curio cabinet at the back of the trolley" and add brief description of preservation concerns regarding the uncertainty of the display cabinet.
- Add language noting the significance of the building being one of the few and unique examples of a trolley car that has been incorporated into a cafe building.

A. HISTORIC PRESERVATION WORK PROGRAM: The Historic Preservation Commission will receive an update regarding the 2019 general work program for Historic Preservation.

HPC LIAISON JENNIFER ALKIRE gave a presentation detailing information as reflected in the January 28, 2019 staff report for the preservation work program.

She commented about information under the headings of Documentation, Protection, Incentives and Outreach and Education as noted in the Staff report.

MEMBERS OF THE COMMISSION AND STAFF discussed in detail information contained in the staff report. The Commission requested an item be placed on an upcoming agenda to recommend additional work plan items including an update of the multi-family historic resources survey and strategies for outreach to owners of single-family properties in lieu of a survey of the R1 zoning districts.

The Commission commented on the Mills Act program update progress, and asked staff for updates on the multi-family historic incentives implementation and status of the 13 remaining properties from the 2008 multi-family historic resources survey that have not yet been brought forward for designation.

## Item 9.A. Public Comment:

VICTOR OMELCZENKO, WEST HOLLYWOOD PRESERVATION ALLIANCE commented on various topics and information relating to Ordinances of neighboring Cities and the 2008 Commercial Survey.

LYNN RUSSELL, WEST HOLLYWOOD commented about previous Surveys addressed in the Work Plan and recommended that the Commission review the City of Santa Monica's 40-Year Plus Threshold Ordinance. She supports previous comments by Commissioner Blaivas.

NELS YOUNGBORG OF CHATTEL INC. addressed concerns about The Lotus. He said the applicant has been responding to the directives previously given by Staff and the Commission and has been actively communicating with the Planning Department.

COMMISSIONER LEVIN restated his comments regarding the passing of Lyndia Lowy.

COMMISSIONER CHARLIE recommended that the annual HPC Event be held at a CRD site and reiterated requests for electronic notification of HPC meetings. He requested updates of previous requests by the Commission and expressed a positon of privilege concerning meeting room temperature. He thanked members of the Community for their and advised that they communicate with impending City Council members concerning HPC issues.

COMMISSIONER OSTERGREN asked about verbatim minutes and informed the Commission about the "Preserving the Recent Past 3" Conference at USC, March 13-16, 2019.
