Request for Proposals (RFP) To deliver social services to members of the West Hollywood community

The City of West Hollywood has been operating social services programs for the community by contracting with non-profit organizations since July, 1985. The City Council has a firm commitment to enhancing the quality of life of the City's community members by meeting their social services needs. For the purposes of social services funding, a West Hollywood community member is: a resident, a person who works in the City, a person who attends school in the City, a property owner, or a person who is homeless and spends the majority of their time in the City.

The City will allocate approximately \$5 million in this funding process to local nonprofit organizations which provide services to meet community need for food and nutrition, employment, and shelter; to care for people whose medical conditions cause need for special services; to encourage community stability, and to enrich the quality of life.

Social services target populations include seniors (with an emphasis on those that are frail and homebound); lesbian, gay, bisexual, transgender, queer, and non-binary community members; women, children, youth and families; Russian immigrants and immigrants who are in the U.S. to protect their safety; people living with disabilities including HIV/AIDS; people who are homeless in the City; people who are at risk of homelessness; and people who are in need due to poverty or low incomes.

Awards are for services for a one-year period, beginning October 1, 2019 to September 30, 2020 with two one-year options for renewal based on continued community need for the service, satisfactory progress toward established program goals, and availability of funding. The City assumes that the second and third-year program and funding is essentially the same.
