REQUEST FOR INFORMATION (RFI)

Pilot Program for Testing of Personal Delivery Devices

City of West Hollywood, California

1.0 Description

The City of West Hollywood (City) is seeking information regarding Personal Delivery Devices (PDDs) for the creation of a pilot program which include a citywide community outreach process.

2.0 Background

Many companies ranging from food to package delivery services are beginning to experiment with autonomous delivery devices. The devices deliver food, groceries, medicine, and packages directly to people's homes and offices. The goal of these devices is to deliver for the "last mile" or the distance from a local depot to the final destination. These devices have been tested in targeted regions instead of vehicles because they can be more cost effective; speed up delivery; use less energy; provide service to residents who are homebound; and reduce traffic congestion and vehicle idle time.

The City has been approached by companies that are interested in working with the City's residents and stakeholders in establishing a pilot program in West Hollywood. The City is taking a proactive role in engaging the community on the topic of autonomous delivery devices. This will include issuing this Request for Information (RFI) to partner with an interested company to collect community feedback, including input from Advisory Boards and Commissions that may have relevant purview. This outreach will help staff determine appropriate options to fit the specific needs of the West Hollywood community and ensure the community's interests are taken into consideration.

A local program in West Hollywood may include establishing a pilot program to allow a company to obtain permits to deploy up to 3 of these autonomous delivery devices in West Hollywood. The framework for the program would enable on-demand commerce while respecting and protecting the public right-of-way. The City and the permitted company would work together to collect data on the effectiveness of the pilot program. The pilot program would ensure that any autonomous delivery devices operating in West Hollywood respect public right-of-way, keep pedestrians safe, meet community demands, and help local businesses.

3.0 Requested Information

The requested information includes the following:

- Cover letter.
- 2. Company Information Name, mailing address, phone number, fax number, and e-mail of designated point of contact.
- 3. Company background a description of the company's background, services and products, business partnerships, target customers and its vision in terms of integrating PDDs in its business model.
- 4. Detailed description and specifications of proposed PDD.
- 5. Locations where PDDs have been deployed and tested and a summary of test results.
- 6. A brief description of the Company's outreach capabilities including key marketing/PR staff and materials for community outreach.
- 7. Provide information on how the company's proposes to operate in West Hollywood, type of products, targeted users and potential partnerships.

4.0 Selection Criteria

The City will select one company to partner with in conducting community outreach which includes meetings with various boards and commissions. Based on the outcome and feedback received, a potential pilot program may be recommended to the City Council. Based on the responses to the RFI, the City will select the company based on the following three selection criteria:

- 1. Experience experience with deployment and testing in other jurisdictions.
- 2. Outreach capabilities experience and staffing for public outreach
- 3. Proposed pilot program approach pilot program approach including management, staffing, contingencies, maintenance robots, operations, safety and oversight.
