**REQUEST:** Proposal to amend the previously approved Robertson Lane Hotel Project. Amendment includes: demolition of two additional buildings (645 and 653-659 N. Robertson Boulevard); retention and rehabilitation of additional area of the Factory Building (cultural resource). Other changes include reduction in overall project area by approximately 921 square-feet; reduction of four guestrooms; reallocation of project area between previously approved uses; changes to the project design and materials; changes to vehicular circulation; no change to number of required parking spaces.
