1. CALL TO ORDER

The Women's Advisory Board Meeting was called to order by Chair Smash-Hyde at 7:16 PM

2. Approval of the May 30, 2019 Meeting Agenda

Approval of the May 30, 2019 Meeting Agenda was motioned by Board Member Eyres, seconded by Board Member Moore, and approved unanimously.

3. Approval of the April 25, 2019 Meeting Minutes Tabled.

4. Public Comment:

John Erickson, President, Hollywood NOW, spoke about item 6.A. He expressed concerns regarding the organization of the women's leadership conference including lack of communication, the exhibitor space, last minute program changes and the use of public funds.

Alana Roshay, Lesbian and Gay Advisory Board Member, spoke about plans for the 2nd annual Bi-Pride and requested the Board's support. She also shared comments regarding item 6.A. including that she was honored to speak at the women's leadership conference, compared this year's conference to a previous one that had greater participation and engagement and suggested revisiting the vision of the conference.

Sepi Shyne, West Hollywood resident, thanked the Board for their work. Spoke about item 6.A. and expressed her support of the women's leadership conference and being

honored to have been a speaker. She expressed concerns regarding miscommunication and lack of communication, last minute changes and low attendance. She also suggested that the City consider the conference event staffing as well as involving female-owned and women-focused businesses.

5. NEW BUSINESS:

A. Sunset Strip Girl Fest

Tabled.

B. Community Screening of Knock Down the House

Chelsea Byers spoke on behalf of National Women's Political Caucus/LA Westside Chapter about organizing a community screening of Netflix's new documentary film "Knock Down the House", to be held along with a panel discussion on July 24, 2019 from 6 pm. - 9 pm. Boardmember Moore made a motion in support of the "Knock Down the House screening with the National Women's Political Caucus/LA Westside Chapter which was seconded by Boardmember Eyres and passed unanimously. Chair Smash Hyde and Boardmember Eyres were designated as liaisons.

6. UNFINISHED BUSINESS:

A. City of West Hollywood Women's Leadership Conference

Boardmember Eyres made a motion for the Board to compile their feedback and that from community members, forward this feedback to the City Council and staff, and request that all concerns be addressed. The motion was seconded by Boardmember Moore and passed unanimously.

B. Domestic Violence Awareness and Advocacy – Family Court System

Vice Chair Lubey reported that there's no movement at this point

C. Women's Equality Day Celebration

The subcommittee reported on planning ideas for the City's annual commemoration of Women's Equality Day, including an activists' type event with Supermajority, a new women's rights organization or a film screening and panel discussion type event. Information about several documentary films was also shared.

D. Women's Safety Joint Subcommittee Report

Staff reported on recommendations from the Women's Safety Joint Subcommittee regarding about sexual violence prevention. Boardmember Eyres made a motion that the City consider exploring the creation of a bystander safety program (aka safe bar program). The motion was seconded by Boardmember Lubey and passed unanimously.

Staff gave a brief update regarding the Board's work plan implementation process.

A. State Legislation & Policy

Staff gave a brief update regarding the state legislative process.

B. Federal Legislation & Policy

Brief updates from staff regarding the status of federal legislation of interest and policy that the Board is tracking. Information was shared regarding the City's actions banning travel to certain states due to discriminatory laws and policies and against the Trump Administration's denial of care rule.

The Board received updates about additional legislation and advocacy issues that have been prioritized by the Board and discussed potential actions.

 Boardmember Eyres made a motion for the Board to endorse both the Citysponsored human trafficking training and the Human Rights Speaker Series
 film screening on human trafficking planned for the fall. The motion was
 seconded by Boardmember Moore and passed unanimously.

She spoke about attending the Mom Congress and advocating for the Momnibus package of legislation. She announced that her company DailyKarma was recently featured in *For*bes.

Boardmember Bleich

She commented about reading the new book by Brett Easton Ellis called *White*, which contains a reference about City of West Hollywood. She announced that she is drafting an Op-ed for *Wehoville* about human trafficking.

Larissa Fooks verified that Board members had received information about riding in the pride parade on the City's float. She gave a brief update about the status of Board reappointments by the City Council.
