# C. APPROVAL OF THE AGENDA

# E. PUBLIC COMMENT

- 1. Julie Smith of Friendly House spoke about the usefulness of that agency's programs, which seek to use the newest science and best practices in their field.
- 2. Alexis Sanchez of the West Hollywood Project provided an update on #SIZZLE!, the alcohol- and substance-free carnival at LAPRIDE. She advocated for funded social services agencies to work collaboratively with other agencies.
- 3. Bamby Salcedo, founder of the TransLatin@ Coalition, spoke about the importance of continuing to provide critical services for all sectors of people in the city.

#### 3. UNFINISHED BUSINESS

# A. HUMAN SERVICES COMMISSION'S REVIEW OF SOCIAL SERVICES PROPOSALS

David Giugni reported that Commissioners had the opportunity to ask questions of Social Services staff and/or agency staff about the social services proposals as soon as they were received. A summary of questions and responses had been provided.

#### **Public Comment:**

- Fred Summers thanked the City for its many years of support for the programs of Jewish Family Service of Los Angeles. He spoke in support of a modest increase for the new funding cycle due to ongoing need.
- 2. Yola Doré spoke about the need to support community members undergoing catastrophic illness. She spoke in support of additional funding for the Senior Center and the LA LGBT Center to address these issues.

Commissioners thanked social services agencies for the work they do for the community, and posed questions to several of the applicant agencies.

Mikko D. Sperber and Jennifer Jorge, representing the Motion Picture and Television Fund, clarified that anyone who has worked in the entertainment business, whether in front of or behind the camera, is eligible for their services. If anyone seeking help is not eligible, they work with partner agencies like Jewish Family Service and Bet Tzedek to help them find services.

Paul Chavez and Chris Clarkin, representing the WeHo Life program at the LA LGBT Center, spoke about the process of review for videos that appear on their website, and discussed the monthly reports of condom distribution.

Tim Alderson, executive director of Seeds of Hope, spoke about the agency's mission of growing and distributing food. They are a community partner with the West Hollywood Community Housing Corporation.

Kiera Pollock, representing the LA LGBT Center's Senior Program, and April Harris and Alla Chasnik, on behalf of Bet Tzedek Legal Services, also responded to questions.

# B. HIV ZERO INITIATIVE YEAR THREE MIDYEAR REPORT

Aaron Celious, Ph.D., the City's consultant for the HIV Zero Initiative, provided a slideshow of information about the accomplishments of the program. The program's goals include expanding access to healthcare for people living with HIV or at elevated risk for acquiring HIV; reducing new HIV infections; reducing HIV-related disparities and health inequalities; and slowing the progression of the disease from HIV to Stage 3 (AIDS).

Public Comment: John Erickson said that women had not been mentioned during the presentation, and recommended more awareness of gender inclusivity, because meetings of this Commission are very male- and cisgender-oriented.

# 4. NEW BUSINESS

# A. EXTENSION OF METRO RAIL SERVICE TO THE CITY OF WEST HOLLYWOOD

Joanna Hankamer and David Fenn of the City's Planning and Development Services Department spoke about work to bring rail service back to West Hollywood, especially by accelerating by 20 years the completion of the Crenshaw Line Northern Extension, currently slated for 2041. West Hollywood Advocates for Metro Rail (WHAM) supports these efforts.
