# HUMAN SERVICES COMMISSION CITY OF WEST HOLLYWOOD SPECIAL MEETING MINUTES JULY 23, 2019 6 PM

# WEST HOLLYWOOD CITY COUNCIL CHAMBERS

### C. APPROVAL OF THE AGENDA

## E. PUBLIC COMMENT

- Nate Clark thanked the members of the Commission for the important work they do for the community and expressed his appreciation of serving with them. He said he hoped the Commission would continue to recognize the needs of families and children in the City, and noted the creation of wehoparents.org.
- 2. Alexis Sanchez of the West Hollywood Project and Safe WeHo Coalition spoke about their analysis of data from surveys completed at #SIZZLE! (LA PRIDE), and #BOOM! (New Year's Eve), with many describing meth as a major problem in the community. She invited the public to attend the Safe WeHo Coalition meetings.

# A. PUBLIC HEARING – SOCIAL SERVICES STAFF'S FUNDING RECOMMENDATIONS FOR 2019-2020 SOCIAL SERVICES CONTRACTS

Commissioner Borelli reviewed the process of determining 2019-2020 Social Services contracts, which has led to the step of holding a Public Hearing for input on the proposals from Social Services agencies.

David Giugni gave an update on the Request for Proposal (RFP) process. He stated that 39 proposals were received by the deadline of June 5, 2019. Nine applicants are not currently contracted Social Services providers, and one current provider, A Safe Refuge, did not reapply. Commission members had the opportunity to provide questions about the applications to staff, who consulted with the agencies when needed. Responses to these questions were provided to the entire Commission on a weekly basis through Friday, June 28, 2019. Staff has completed its recommendations and spoke with all applicants to advise them of the recommendations and to encourage them to attend this meeting.

David Giugni highlighted six agencies being recommended for funding which are not currently contracted with the City for service: Awakening Recovery, Inc., JQ International, Los Angeles LGBT Center Senior Services, Seeds of Hope, Trans Can Work, Inc., and the TransLatin@ Coalition. He also highlighted 13 agencies recommended to provide enhanced services: Alliance for Housing & Healing, APLA Health & Wellness, Ascencia, Being Alive, Bet Tzedek, Friends Research Institute, JFS Comprehensive Services Center, JFS SOVA Food Pantry, Los Angeles LGBT Center's Services for Homeless Youth, Los Angeles LGBT Center's Transgender Economic Empowerment Project (TEEP), NCJW's Rental Assistance Program, Saban Community Clinic, and Step Up on Second.

The proposed contracts run from October 1, 2019, to September 30, 2020, and can be renewed.

The Commissioners thanked the social services agencies for their positive impact on the community, and thanked their representatives and proponents for attending. Commissioners posed questions to staff regarding their recommendations about applicant agencies, including Saban Community Clinic; Los Angeles LGBT Center; WeHo Life; McIntyre House; Step Up on Second; Friendly House; Awakening Recovery, Inc.; the Motion Picture and Television Fund; Disability Community Resource

Center; Jewish Family Service; Bet Tzedek; and agencies providing housing assistance.

# 6. ITEMS FROM STAFF:

David Giugni stated that the next agenda will include the selection of a representative to the Complete Count Committee, which will develop ways to ensure that every resident will be fully counted in the 2020 US Census.

David Giugni said staff is working with Dr. Aaron Celious regarding aspects of the HIV Zero report, and they anticipate having an update on an upcoming agenda.

### 8. ITEMS FROM COMMISSIONERS:

Commissioner Palmieri spoke about the need to find out why there was such a low level of PrEP use in the community. Commissioner Davis noted the importance of filling the office of Vice Chair and asked for it to be included on the next agenda. Commissioners thanked agency representatives for attending, thanked staff for developing the recommendations to be considered at the next meeting, and thanked Nate Clark for his hard work as a member of the Human Services Commission.
