# Request for Proposals (RFP) for Implementing Senate Bill 743

The City of West Hollywood invites qualified firms to respond to this RFP for Senate Bill (SB) 743 implementation services. The City has recently updated its travel demand model and it is available for use in the development of vehicle miles traveled (VMT) based methodology to evaluate development projects consistent with CEQA requirements. The City has also conducted a Trip Generation Study of hotels, restaurants and senior/assisted living facilities within the City to aid in this effort as well.

To further these initial steps, the City seeks a qualified firm to assist in the development of a VMT methodology, a VMT calculator, VMT thresholds evaluation and recommendations, VMT mitigation options, the development of traffic impact study guidelines, and the development of a transportation development review fee. The scope of work also includes leading study sessions and outreach to stakeholders as part of the adoption process.
