This preliminary application is provided pursuant to Section 65941.1 of the California Government Code for housing development projects. All requested information must be provided and applicable fees paid in order for this application to be considered submitted to the City. This preliminary application does not take the place of the entitlement application that is required for submittal to the City for consideration of a housing development project.

The entitlement application for the housing development project, including all the information required to process the entitlement application, must be submitted to the City within 180 calendar days after the submittal of this preliminary application. If the appropriate entitlement application(s) are not submitted within 180 calendar days, the rights granted by this preliminary application shall become null and void.

If, after submittal of this preliminary application, an applicant revises a housing development such that the number of residential units or square footage of construction changes by 20 percent or more, the housing development project shall not be considered to have submitted a valid preliminary application until the applicant resubmits the information to reflect the project revisions. If the applicant revises this preliminary application in any other way, including to revise any previously incorrect information, the preliminary application shall be deemed "submitted" on the date the revised, accurate information is submitted to the City.

FILING FEE
