10. PUBLIC HEARINGS

A. 13. ITEMS FROM STAFF

A. 24-Hour Fitness: Update on outstanding issues

Commissioner Torgan recused himself from the subject.

Francie Stefan presented a report on the outstanding issues that 24-Hour Fitness is complying with.

Public Comment:

- 1. Todd Elliot, West Hollywood, informed the Commission on the remedies that 24-Hour Fitness is taking to reduce noise from the air conditioning units, an issue regarding loading and storage spaces, and parking concerns of the neighbors.
- 2. James Litz, West Hollywood, reported on his tour of 24-Hour Fitness with Todd Elliot and stated that the club has resolved some issues and a permanent 24hour number will need to be provided for neighbors to call during non-operation hours. Also stated that there is more parking on the streets since the parking permits expired in March and isn't sure how the City will continue to monitor the parking situation.
- 3. Alexa Cantu, West Hollywood, gave a brief history of the air conditioning system and the club is taking steps to resolve the noise issue that includes installing timers on the units to shut them off during non-operating hours. Also reported that Gina Koon, District Operations Manager, will be the 24 hour contact person for the gym.

Commissioner Comments

DeLuccio – Thanked 24-Hour Fitness for providing an interim emergency number to the residents and to the City. Inquired as to who is responsible for the air conditioning units. Pleased that there is more communication between the gym and neighbors.

Hamaker – Inquired if the weight of the air conditioner is standard for the building.
