#### 7. PUBLIC HEARINGS

A. Conditional Use Permit 00-21, Development Permits 00-61 and 00-19, and Variance 00-61 (Amend approved permits): Reduce approved parking for new building including auditorium and classrooms to provide 50 additional spaces rather than 100 spaces.

Applicant: Center for Early Education

Location: 563 N. Alfred Street

Planner: Liz Bar-El

**Recommendation:** Deny without prejudice.

Liz Bar-El presented the staff report.

Terri Slimmer, Department of Transportation Manager, presented a report on the traffic and parking requirements and shared her experience of monitoring traffic in the Rosewood/Alfred Street area.

Dale Goldsmith and Jim Ostrom presented the applicant's report.

#### **Public Comment:**

- Reveta Bowers, Los Angeles, spoke on behalf of the Center and described the function of the proposed auditorium and asked the commission not to place restrictions on the auditorium use.
- 2. Alicia de Soto Foley, West Hollywood, spoke as a parent whose child attends the school and stated that the parents would be happy to abide by conditions placed on the school by the Commission so that the new building can be built.
- Jeanne Dobrin, West Hollywood, supports the approval of this project and commended the Center for its efforts to mitigate parking and traffic impacts on the community.

4. Dave Sykora, Tustin, consultant for the City's Seismic Safety Element, spoke as an expert on geo-groundwater and stated that the ground water in this area is very shallow. Artesian conditions probably occur randomly throughout the area are is not necessarily unique to this site.

Dale Goldsmith presented the applicant's rebuttal.

#### Discussion:

- Artesian water on the site has been substantiated as being unique and therefore qualifies the applicant for a variance.
- Dissention from some commissioners who stated that there are not special circumstances at this property to meet the variance requirement.
- Add condition to limit number of new students to twelve per year.
- Add condition to be included into parents enrollment agreement with the school.
- A through E to be conditions for mitigated negative declaration.
- The City will not be able to enforce the additional conditions imposed by the Commission.
- Review of a traffic analysis is necessary to determine if parking requirement is adequate.

Action: To reject staff's recommendation and approve Variance 00-16 and the related entitlements with some amendments and adopt a mitigated negative declaration.

A. General Plan Amendment 99-05 and 01-01: Amend Seismic Element of General

Plan.

Applicant: City of West Hollywood

Location: City-wide **Planner:** Tim Foy

Recommendation: Discuss and provide input to staff and agendize a public

hearing for General Plan Amendment 99-05.

Tim Foy outlined the discussion to take place.

Dave Sykora spoke about the Fault Precaution Zones location to include:

- Fourteen fault location studies have been conducted.
- In the FP1 precaution zone, a fault location study should be conducted.
- In the FP2 precaution zone, a fault location study should be conducted or the engineering improved to handle displacement since 1000 feet thick all uvium over bedrock will not cause any substantial damage should the fault rupture.
- Currently not recommending Santa Monica fault as a fault precaution zone.
- Single family home should be exempted from fault location studies.

Action: Agendize to May 17, 2001.
