### 6. PUBLIC HEARING

C. Conditional Use Permit 99-34 and Variance 99-22: Continued hearing on the modification of service station design standards and CUP Amendment to allow a third driveway into the Mobil Service Station from Santa Monica Boulevard.

Applicant: Mark Lehman for Kasey Kashani and the Mobil Station

Location: 8380 Santa Monica Boulevard

Planner: John Keho

Recommendation: Deny the request.

John Keho presented the staff report.

Mark Lehman presented the applicant's report.

## **Public Comment:**

- A. Kasey Kashani, Los Angeles, stated the problems that the customers have maneuvering in and out of the station and it has deterred customers from coming to the station. The revenues of the station have also dropped.
- **B.** Jeff Griffin, Beverly Hills, commented on the driveway and the traffic light that used to be there and how difficult it is now for customers to enter and exit the station. He also stated that business has decreased since the driveway was blocked off.
- C. Diane DeMarco, West Hollywood, stated that she has been a long time customer of the station because of it's great service, but has not been going due to the difficulty she encounters trying to get in and out of the station. She is in favor of the driveway being re-installed at the station.
- **D. Douglas Fortunato, West Hollywood,** stated how difficult it has been to get into the station and creates a hazard for customers and pedestrians.
- E. Jeanne Dobrin, West Hollywood, said she has not been in the driveway of the Mobil station but knows how difficult it is from her experience with similar

driveways. Suggested that the driveway be widened and to deny the appeal for the center driveway.

Mark Lehman gave a rebuttal.

D. Rehabilitation Incentive 00-01 and Conditional Use Permit 00-07: Rehabilitation incentives for historic structures and conditional use permit to legalize the existing San Vicente Inn and allow for the expansion of the Inn into an additional historic building.

Applicant: Gene Smith for the San Vicente Inn Location: 837, 845, 849 and 850 San Vicente Blvd.

Planner: John Keho

Recommendation: Conditionally approve the request subject to the findings and

conditions in the proposed resolution.

Gene Smith presented the applicant's report.

## **Public Comment:**

- A. Todd Bianco, West Hollywood, stated that he lives around the corner from the Inn and has not encountered a parking problem. He also stated that the Inn is a Unique place and should be preserved and spoke in support of the item.
- **B.** Greg LeCuyer, West Hollywood, commented on the Inn and that parking has not been a problem.
- C. Neil Zaslavsky, West Hollywood, gave economic statistics to the city by the guests' and urged the Commission to approve the item.
- **D.** Michael Pober, West Hollywood, commented on the Inn's and how well they have been maintained and has not encountered any parking problems.
- E. Dawn Sandor, West Hollywood, spoke in support of the Inn's, the terrific job the owner's have done to keep up the buildings and what good neighbors they have been.
- F. Ingve Sjolund, West Hollywood, spoke in support of the Inn's and how well the owner's have kept the Inn's as a welcome center as well as provide jobs to residents.
- **G. Jerome Cleary, West Hollywood,** spoke in support of the Inn's and how well they are operated and needed in the City. Urged the commission to approve the item.
- H. Jeff Samudio, Los Angeles, informed the commission of the Historic American Building Survey Documentation for the San Vicente Inn's that he and his firm

documented. He stated that the incentives being sought are in line with other incentives through out the State. He is in support of the item and urges the Commission to approve the requests'.

I. Jeanne Dobrin, West Hollywood, stated that the buildings should exist as one entity; Condition 11.13 in the CUP should be monitored by the Transportation Department; stated that she is in support of the Villa's.

Gene Smith presented a rebuttal statement.

Commissioner Behr asked if parking vehicles in the front yard was appropriate.

John Keho indicated that the while this is not ideal it is the best solution because otherwise the parking would need to be placed at the rear of the structures and would result in the loss of the common pool space.

Commissioner Crowe suggested an amendment that would require the San Vicente Inn to submit a recordable covenant running with the land that:

- a) guaranteeing to continue the operation and maintenance of the project as a unified development;
- b) guaranteeing the continued maintenance of the unifying design elements; and
- c) specifying an individual or entity to be responsible for the operation and maintenance of the development.
