- 3. Elizibaeth Hradsky, West Hollywood, stated that there is not any noise from the day time parking, only from the valet's at night.
- **4. Jeanne Dobrin**, West Hollywood, inquired how Mr. Karmani got permission to remove the trees; said she doesn't know why staff allows businesses to expand if there isn't ample parking; and believes the Commission should uphold the staff recommendation and deny the request.
