A. Variance 98-06, Billboard Permit 98-16: A variance from the 45-foot height limit to permit the replacement of an east face of a two-sided billboard with a vertical billboard that would be 81 feet 8 inches tall.

- c. Commissioner Smith stated that there was a neighborhood meeting of the PDC and commended Hassan Haghani. He also commended Ray Reynolds for last night's SMBASC. The issue of trees was decided on. Artistic and landscape treatments of bus stops were also suggested.
- d. Commissioner DeLuccio stated that the Plummer Park Advisory Committee would be having a joint meeting with the Public Facilities Commission on Wednesday, September 9 to discuss the proposed Community Center.
- e. Commissioner Crowe stated that at the last DRC meeting, they reviewed several new projects on Sunset. Also, Sav-On windows need to be investigated to meet their conditions in their CUP.
