B. Revocation of Substitute Conditional Use Permit 93-09

Recommendation:

Modify the SCUP based on the finding that the Club was operating as a nuisance, that it was operating in violation of its conditions of approval

and that the findings upon which the permit was issued could no longer

be made in a positive manner.

Ms. Heep presented the staff report.

The Commission discussed the following:

- License transfer/applicability of conditions
- Holder of liquor license
- Required parking
- Restrictions based on former nightclub operator

Commissioner Smith disclosed that he had spoken with many people regarding project and has visited the site.

Commissioner Behr disclosed that he has had discussions with Bettie Wagner.

Commissioner Crowe disclosed that he had spoken with Ira Handelman.

Commissioner DeLuccio disclosed that he had visited the site and had a telephone conversation with Ira Hendleman.

Commissioner Altschul disclosed that he met with Steve Strauss, and Mr. Davis and Mr. Davis. Commissioner Jones disclosed that he has been to neighborhood meetings and never been in building.

Ms. Jane McCabe, Alcohol and Beverage Control, discussed with the Commission:

- Suspension of license on September 4 for 15 days
- Permanency of conditions
- Tandem parking
- Transferring of another license to this location
- Preference for parking under City's jurisdiction
- **a.** Steve Strauss, Owner's Representative, West Hollywood, commented on "Player's Club" project and that he is in favor of modification of SCUP.

The Commission discussed the following:

- Bathroom facilities
- Occupancy
- Parking compliance
- Sprinkler system
- Association with former club operators
- Employee parking plan
- Type of music performed
- Noticed neighborhood meeting
- No promoters
- Special events
- Process of modification/revocation of SCUP
- **b. Julie Summers**, West Hollywood, commented on traffic and parking problems, fines/infractions should be applied to the SCUP.
- c. David Naylor, Los Angeles, expressed concerns regarding neighborhood problems.
- **d.** James Mandelbaum, Los Angeles, commented that he is in favor of revocation because of unresponsive absentee landlord and the numbers of nearby clubs.
- e. Laurence Gosenfeld, Los Angeles, commented that there are consistent problems of noise and traffic; parking garage would resolve problem.
- **f. Clive Baille**, Los Angeles, expressed that he would like this to be revoked, just like Dublin's location, where this has worked.
- **g. Steve Byrnes**, Los Angeles, commented that he is in favor of revocation because operators could be gone in a year and a new owner/operator could be as bad.
- h. **Jimmy Bryant**, Los Angeles, commented that he is representing residents in his building on Crescent Heights because traffic is bad.
- Hub Braden, Los Angeles, commented that problems in neighborhood are due to traffic from club.
- i. Michelle McGrath, West Hollywood, expressed that she is in favor of revocation.
- k. Bettie Wagner, Los Angeles, commented that she is in favor of revocation and that she received an anonymous message on her answering machine stating that the Planning Commission had been paid off by the owner. Commissioner Altschul stated that she turn this matter over to the Sheriff's Department.

Action: To close the public hearing.

Motion: Crowe Second: Behr Votes: All Ayes Motion carried.

Action: To re-open the public hearing.

Motion: Crowe Second: Behr Votes: All Ayes Motion carried

Ms. Margaret Lynch, stated that her family owns the property and that she designates Mr. Strauss as her representative.

Mr. Strauss rebutted.

I. Joe Sutton, Los Angeles, commented that he is in favor of revocation, although he is a partner in Billboard Live.

Mr. Strauss rebutted.

Action: To close the public hearing.

Motion: Crowe Second: Jones Votes: All Ayes Motion carried.

Action: To determine that the club was operating as a nuisance.

Motion: Crowe Second: DeLuccio Votes: All Ayes Motion carried.

Ms. Susskind explained revocation and modification processes.

The Commission discussed:

- Staff's reasons behind recommendation
- Modification versus revocation process and effect on future application processes

The Commission directed staff to include the following conditions in the draft of a modified SCUP:

- Option for City Engineer to require retaining wall be adjusted
- Landscaping (streetscape and parking lot)
- Enclose current parking lot
- Direct lights in parking lot away from residents
- Doors on 3rd floor modified to be vestibule to minimize sound to streets
- Free employee parking
- Noticed review in 6-12 months
- No Certificate of Occupancy unless all noise issues are resolved
- No outside promoters
- Sufficient time be given between shows
- Moderate valet parking charge
- Traffic control plan
- No crowds on driveway
- · No alcohol and food service outside
- Cost recovery plan
- Security plan
- Compliance with current bathroom standards
- Parking/circulation plan (specifically to resolve back-up along Sunset Blvd.)
- Adjacent lot use for parking, close to 81 spaces

- Include ABC conditions regarding no promoters and parking provisions
- No specific language for any particular style of architecture
- Compliance with ABC conditions or incorporate specific conditions from ABC.

This hearing has been continued to a date to be determined by staff.

8. ITEMS FROM COMMISSIONERS

- a. Commissioner Jones thanked Mr. Reynolds for providing answers expediently regarding Ticketmaster's trees and telephone number under their sign, rug company's regarding going-out-of-business sign (at corner of Melrose/San Vicente), and parking lot at Melrose/La Cienega.
- b. Commissioner Behr thanked City Staff regarding graffiti removal.
- c. Commissioner Smith lauded Ms. Heep for a fine report on Roxbury.
- d. Commissioner DeLuccio echoed Commissioner Smith's comments and inquired about revised elevations for HOB parking to be reviewed by Design Review Subcommittee. Ms. Heep stated that she will look into this.
