Ms. Heep stated that there were new materials submitted: crime statistics from January through April and letter from Joel Fries, date May 2, 1996.

Mr. Meyer presented the staff report.

Ms. Susskind discussed the revocation procedures, two items to be part of the record -- May 2, 1996 letter from Joel Freis and public testimony from Jim Norvold in favor of revocation, and inquired whether the Commissioners have had prior discussions regarding this project.

Commissioner Litz stated that he had spoken to the president of the Chamber of Commerce, and has been in contact with Mr. Freis.

Commissioner Jones stated that he had not spoken to anyone regarding this case nor visited the site.

Commissioner Behr stated that he had contacted ABC regarding type of license the club had obtained when they began operation.

Commissioner Lambert stated that he has not been in contact with anyone but has driven by the site.

Commissioner Smith stated that he has not been in contact with anyone but has received Mr. Freis' letter, yet not read it.

Commissioner Crowe stated that he has not been in contact with anyone regarding this case.

Commissioner Fischer commented that the letter from Joel Freis was delivered to her the night before, and spoke to Bob Burke who had been retained by the permittee.

- a. Joel Fries, representing permittee for Sunset Room, presented his case.

- d. **Kevin Brady**, Los Angeles, commented that he was a former co-owner with the permittee of this nightclub and is in favor of revocation.
- e. Jimmy Blondell, Venice, commented that he was a former nightclub manager for this site and is in favor of revocation.
- f. **Jeanne Dobrin**, West Hollywood, commented that she is in favor of revocation.
- g. Arlen H. Andelson, Los Angeles, commented that he is co-counsel for permittee and is opposed to revocation.

Mr. Freis rebutted.

The Commission inquired Mr. Freis regarding the following:

- hours of operation
- timeframe for client's relationship with lawyer
- crime
- occupancy load
- and control of overcrowding

Mr. Goldman stated responses to club are usually misdemeanor charges and that crime has increased in recent months.

Captain Odenthal commented that there are also incidents of drunk driving.
