Ms. Bar-El presented the staff report.

- a. Franklin Cole, Applicant, commented on history of cellular phone services; there have been no complaints on the antennae; and responded to questions from the Commission.
- Dr. Jerry Bushford, Sacramento, commented on health effects on humans from microwave (medium for cellular phone technology); and there is current research on this issue.

# C. Rage Outdoor Dining (CUP 95-08)

Request to amend existing permit to include outdoor dining and allow service of alcoholic beverages.

Recommendation:

Approve CUP 95-08 subject to the conditions set forth by the proposed draft Resolution PC 95-39.

Ms. Kozlowski presented the staff report; would like project to be continued to September 7, 1995.

a. Jeanne Dobrin, West Hollywood, commented that she obtained the CUP from 1993, the staff report did not include the county CUP, the project was conditioned to have 67 on-site parking spaces (62 in the lot, and 5 behind), until October 1984 there were no off-site parking lots in the county, private deals regarding parking spaces, height and density bonus for 825 San Vicente for 6 residential units, complained to Environmental Services staff regarding trash lids and coverage of dumpsters, and reduction of kitchen size.

The Commission directed staff to change Item 5c in Resolution PC 95-39, page 4, regarding distance from residential uses.

The Commission requested additional information be provided in the next staff report:

- actual food service at Rage
- ABC license and county CUP
- sidewalk widths & seating plan

- · relocation of newspaper stands
- · and sidewalk cleanliness

This will be continued to September 7, 1995.

# D. Nightclub Parking Standards (Zoning Text Amendment 94-05)

Hearing concerning revised parking standards for nightclubs.

Mr. Foy presented the staff report; responded to Commissioner's questions.

Ms. Rhodes commented on parking leases versus covenanted leases and parking availability study for West Hollywood.

a. Jeanne Dobrin, West Hollywood, commented that parking and crime were once the main problems; the main problems now are parking and circulation; all public assembly uses should be included as part of this amendment; Spartacus (Rage) is case-in-point, in contrast is Le Dome Restaurant; City of Beverly Hills requires cross-covenanted leases and is recorded; would like the City to have "stings" on nightclubs and prosecution.

The Commission discussed:

- leases (acquirement and losses)
- occupancy
- requirement to file a certain amount of time prior to special events that would require additional parking spaces.

Mr. Mullins commented on occupancy load and floor plans.

The Commission directed staff to amend to the Resolution the following:

- Item 1e(i), to read "For the floor plan...all other nightclub areas...."
- addition item requiring approval by the Community Development Director any slight modifications (± 10% deviations from the occupancy load on the plans approved by the Commission, with maximum of fifteen persons change), with specific findings
- add to 3g(ii) a clause regarding how far in advance clubs must inform the City about using second tier spaces.

#### VI. COMMISSION CONSIDERATION

# A. Discussion of Amending the Planning Commission Bylaws

The Commission agreed that subcommittees should not consist of more than two Planning Commissioners, when there are less than a total of six Commissioners .

Action: To amend Resolution 92-31 (Planning Commission Bylaws), Section 18, to state that when there are five or fewer Commissioners present, that three votes would be sufficient for a majority vote (four affirmative votes are required to change the bylaws); also, delete section regarding Commission's abstained votes counting towards quorum.

### VII. ITEMS FROM CITIZENS

a. Jeanne Dobrin, West Hollywood, commended the Commission for their work on the nightclub parking standards issue; commented that the City Council does not have to disclose ex parte; Scandia is owned by Don Cornelius (host of Soul Train) expressed her concern that it would be converted into a nightclub; Rainbow allows smoking at various times of the day - their condition regarding nightclub/restaurant may be the reason.

### VIII. ITEMS FROM COMMISSIONERS

- a. Commissioner Fischer commented that the California Chapter of the American Planning Association Conference on September 30, 1995; inquired if funds were available from the budget for attendance.
- b. Commissioner Behr inquired into the Metropolitan Community Church's (MCC) negotiations regarding the purchase of building in West Hollywood; Ms. Heep commented that they are aware of the parking and CUP requirements.
- c. Commissioner Jones inquired into the security guards for Roxbury.
- d. Commissioner Litz welcomed MCC to West Hollywood and expressed that he would like the organization to work with staff. On August 27th there is a special event at the old City Hall parking lot; would like them to get their permit for this. There is an APA Planning Commission workshop on September 16, 1995 at AQMD headquarters in Diamond Bar. On Saturday August 26, 1995, the City is cosponsoring a first-time homebuyers workshop at the Werle Building from 10 a.m. to 1 p.m.; for more information call (213)848- 6448.

### IX. ITEMS FROM STAFF

a. Ms. Heep stated that she distributed a list of the Planning Priorities to the Commission; she also met with the neighborhood of the Norma Triangle (who have appealed to the City Council regarding Variance 95-02) to discuss long-term goals regarding amendment to the Zoning Ordinance on the issue of lot sizes. The Commission stated that they would like to discuss the priorities list after the City Council has discussed this.
