- b. Jeanne Dobrin, West Hollywood, commented that she understands Mr. Yarbrough's concerns since one of the adjacent properties is Eclipse Restaurant, on the 9009 Elevado variance application and Mr. Guilaroff's application, and that the Planning Commission should approve the variance.
- c. Mark Lehman, the Applicant's representative, commented on the topography and that the wall is aesthetically pleasing.
