Mark Lehman, W. Hollywood (representative for applicant), rebutted public testimony, and the architect responded to questions and concerns of the Planning Commission and neighboring residents.

To keep the public hearing open, continue the item to the next Planning Commission meeting, and direct staff to look into the possible issues: 1) Noise condition to project so that no sound is audible from five feet away, and all doors to the club should be closed during hours of operation; 2) Queuing should be prohibited; 3) Security - require a unified security program for the club and all off-site lots. Failure to require this could result in revocation of the permit; 4) Litter - should be removed daily within a 400 foot radius of the club; 5) Operations - limit hours of trash pick-up and deliveries, limit hours of drinking and dining, and require a 24-hour hotline for complaints;
6) Special Events - should be limited and residents be notified in advance; 7) Occupancy - to be determined based on the amount of tables and chairs in seating areas; 8) Traffic - use of barricades and metered spaces on the northside of Sunset as a carriage lane after 9:00 PM; 9) Parking - Require 100 parking spaces at the 9000 Building, determine a minimum number of parking spaces, and review the condition that the City of Los Angeles uses regarding where patrons park; and 10) Review suggested conditions by the public and increase size of "designated drive" sign.
