A. Approval of Resolutions

1. Resolution No. PC 93-32, "A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF WEST HOLLYWOOD APPROVING DEVELOPMENT PERMIT 93-23, CONDITIONAL USE PERMIT 93-07 AND PARKING USE PERMIT 93-08 ON AN APPLICATION FILED BY KEITH PRESSMAN TO REMODEL AND EXPAND THE STRUCTURE LOCATED AT 9039 SUNSET BOULEVARD, BY ADDING OUTDOOR DINING, UPGRADING TO MEET NIGHTCLUB STANDARDS, AND SECURING SHARED PARKING OFF-SITE."

1) Condition 1.6 should include, "The permittee shall notify the City within thirty (30) days of any change of ownership or use of the property for which the spaces are required, and of any termination or default of the agreement between the parties"; 2) Condition 1.7 should read, ... "related to nightclubs as mandated in the Sunset Specific Plan or other mechanism;" 3) Condition 2.1 should read, It will feature popular live and recorded music "and be geared toward a sophisticated and mature clientele";
4) Condition 2.1, add ... removal of tables and chairs and/or the elimination ...; 5) Last sentence on Condition 7.0 should read, "A landscaped buffer shall be required along the northern property line."; 6) Condition 10.1 starts with, "Prior to issuance of a building permit, the applicant shall submit a valet parking .."; 7) Condition 11.7 should state, "This permit shall be reviewed six months from the date that operations commence; 8) Condition 11.9 makes the applicant responsible for litter removal on the following: Wetherly to Shoreham, Doheny to

Shoreham, and Shoreham, between Doheny and Wetherly, <u>all</u> <u>on both sides;</u> 9) Condition 11.13 should include, "The club shall designate at least three people who are in charge of the complaint log for the purpose of making entries into the book; and 10) The use of flyers or handbills which are placed on windshields or posted on public property including, but not limited to light posts, is prohibited.
