VII. ITEMS FROM CITIZENS

Stan Lothridge, West Hollywood, thanked the Planning for revoking Development Permits 89-09 and 89-10.

VIII. ITEMS FROM COMMISSIONERS

- Commissioner Richmond spoke on the following:
 - A speaker's time limited to two minutes and letting a speaker combine time periods of other speakers who wish to donate their time;

- 2. The City's policy permitting underground parking in residential areas where water table is low; and
- 3. Suggested that the City work on developing data and technical information to help address problems associated with construction.
- B. Commissioner Crowe talked about exploring engineering options to deal with residential areas who experience problems with water table and indicated that it common knowledge that high water tables exist in West Hollywood.
- C. Commissioner Litz discussed the following:
 - Engineering concerns about construction in high water table zones;
 - Making it mandatory for developers to post bonds to protect the City potential problems after issuance of development permits; and
 - 3. The Howard Stern incident and the City's requirement that Stern put up a bond. Commissioner Litz indicated that the City's permitting process is inconsistent.
- D. Commissioner Lambert inquired if the high water table table zones issue was addressed in the West Hollywood General Plan and informed the Commission of the upcoming SCAG workshops.
- E. Commissioner Behr spoke on the following:
 - 1. If a map could be produced by the City to identify high water table areas in the City:
 - 2. Promissory notes;
 - 3. Agreed that special events need to be better defined;
 - 4. The Pacific Design Center parking lot study; and
 - 5. Commented on a banner hanging over the sidewalk on Santa Monica Boulevard which states that children who ride bikes need to wear safety helmets.
- F. Commissioner Zaden spoke/inquired on the following:
 - Special events need to be better defined;
 - Requested a report on status of property on 1145 Horn Avenue;

- 3. Informed the Commission that the Horn/Sunset area parking restriction signs near Spago's restaurant are faded; and
- 4. Asked for a Council retreat.
- G. Commissioner Loveman reported that he and Commissioner Litz attended a meeting with staff regarding transfer development rights and will be getting a report shortly. He commented on a banner hanging over the sidewalk on Santa Monica Boulevard which states that children who ride bikes need to wear safety helmets.
