Permit 90-49 differed from the motion made by Planning Commission regarding the provision of replacement open space.

VIII. ITEMS FROM COMMISSIONERS

- A. Commissioner Behr asked how projects with conditions or review periods with time limits are reviewed by staff.

 Anne Browning explained the function of the Tickler File.
- B. Commissioner Richmond inquired when the Cultural Heritage Advisory Board and City Council study session is scheduled.
- C. Commissioner Zaden brought up the following:
 - 1) On 8940 Dicks Street, there is a large wood facade with electrical boxes and exposed wiring.
 - 2) On 1117 Sherbourne, there is a sofa that has been lying out for some time on the street and the sidewalk down Sunset Boulevard is covered with dead stuff from trees. She requested staff to check on both properties.
- D. Commissioner Clavan talked on the following:
 - 1) Questioned procedures during meetings, particularly as to the time given to various speakers. He thought the Commission agreed not to extend time to anyone.
 - Continuation of the designation of the Sherman District.
- E. Commissioner Litz mentioned seeing a Sunset Plaza advertisement showing the property as part of Los Angeles.

- A. Anne Browning talked about a designation which is coming before the Commission on April 18, 1991, and whether the Commission wants to continue it.
- B. Anne Browning gave an update on the Sunset Boulevard Specific Plan.
