II. ITEMS FROM CITIZENS

A. Bruce Traub, West Hollywood, spoke on benefits of the Raleigh Project and how this relates to the strategic plan; and why some owners pay a fee for condo conversion while other owners do not. Staff explained that if the condo is owner occupied, it is not necessary to pay a fee.

B. Jeanne Dobrin, West Hollywood, concurred with Bruce Traub's comments. While she suggested that half of art fee of the Raleigh project be contributed to Hart Park, she stressed that all the benefit assessments should be on site, especially for a meeting place for citizens.

V. COMMISSION CONSIDERATION

(The appeal was approved by the Planning Commission on January 17, 1991, effectively denying the demolition permit. However, findings in support of the denial could not be made by the Commission at that time).

Anne Browning presented the staff report. Brent Mullins, Building and Safety Manager, gave additional information on the project.

Jon Enright, applicant/architect, spoke on materials used to secure property and parking issues.

Action: To approve demolition of the property with the following conditions: lighting on the property should be included for safety factors and should not interfere with surrounding houses; no surface parking will be permitted (a TUP for parking will not be issued by staff); setback of 8 feet on landscaping to act as buffer; and proof of ownership to be submitted. A fence of 12 feet will be built on the rear while the front and sides would have a minimum of 8 feet. The architect is requested to submit a fence design to be reviewed and approved by the Design Review Subcommittee of the Planning Commission.
