A. Jeanne Dobrin, West Hollywood, talked on public noticing.

B. David Ynes, West Hollywood, mentioned that he has not received any public notices and voiced his observation on some conditions on the Historic Preservation Ordinance which he feels are being ignored.

III. CONSENT CALENDAR

- A. Approval of Resolutions
 - 1. Resolution No. PC 90-13 of the Planning Commission of the City of est Hollywood approving Minor Conditional Use Permit 90-05 on an application of Jerome Buckmelter for L.A. Cellular to permit the development and operation of a commercial cellular telephone facility with roof-mounted antennas at 8151 Santa Monica Boulevard.

Anosh Ishak and Yair Koshet rebutted public testimony.

Action: Accept staff's recommendation and continue Development Permits No. 90-05 and 90-06; Demolition Permits 90-05 and 90-06; Conditional Use Permit 90-03 and 90-04; Tentative Tract Map 22025 and 22024 to a date uncertain. Issues regarding entry areas, habitable spaces and parking should be modified. Also reduce the appearance of bulk; and that the redesign recommendations in the staff report be followed.

VI. COMMISSION CONSIDERATION

Α. Demolition Permit 90-09 and tandem parking request for 8920 Cynthia Street.

John Jakupcak gave the staff report.

Jeanne Dobrin, West Hollywood, commented on the project.

Action: To deny the request for tandem parking based on the findings that it would be demolishing an existing garage and replacing it with tandem parking; it would be intensifying the area without providing additional parking; other alternatives should be explored on how to deal with the dilapidated structure.

The Planning Commission decided not to take action on the Demolition Permit at the present time.

B. Discussion of the City's Five Year Capital Improvement Plan.

Commissioners Litz and Gene Smith submitted a written report which included the sewer system, neighborhood traffic improvement, median strip improvement, street-scape to create assessment districts, affordable housing, etc., and the Commission discussed the different aspects of this plan.

C. Art in Public Places Policy.

The Commission reviewed the Art in Public Places Policy and draft memorandum to the Fine Arts Advisory Board. The Commission requested that a memo be sent to the City Council rather than the Fine Arts Advisory Board.

D. Strategic Planning - Discussion of Values.

The Planning Manager gave a report on the strategic plan.

VII. ITEMS FROM COMMISSIONERS

- A. Commissioner Richmond brought up the rotation of officers and inquired about the City Hall Site Selection Committee.
- B. Commissioner Gene Smith requested a development of design standards for parking.

VIII. ITEMS FROM STAFF

A. The Planning Manager informed the Commission that there will be no cable service for the next meeting and that there will be no public hearing until the end of July.

The Commission decided to cancel the June 21st meeting.

Before adjourning, Commissioners and staff members recognized and thanked Commissioner Siegel for his work with the Planning Commission for four and one-half years.
