II. ITEMS FROM CITIZENS

- A. Mike Radcliffe, West Hollywood, spoke on 1033 S. La Brea. He inquired why this project never came before the Planning Commission.
- B. Edward Riney, West Hollywood, represented the East End Community Alliance. He supported Mike Radcliffe and emphasized that and Environmental Impact Report is needed for 1033 S. La Brea.
- C. Roslyn Krause, West Hollywood, complained about the pool area, vagrants using the shower, and no lifeguard to complain to. She also mentioned that at one time there was no lifeguard at the pool for about 45 minutes.
- D. Barbara Parrish, West Hollywood, spoke on behalf of homeowners in Rugby Drive. She presented petitions from residents who were requesting downzoning of the area from R3 to R2.
- E. Stan Lothridge, West Hollywood, also spoke on Rugby Drive and supported the request of downzoning of the area.
- F. Jeanne Dobrin, West Hollywood, supported Mike Radcliffe and Edward Riney and their request for an EIR for the project at 1033 S. La Brea. She brought to the attention of the Planning Commission the flashing sign on La Cienega and Santa Monica.

A. Approval of Resolutions

Adoption of Resolution No. PC 90-17, "A Resolution of the Planning Commission of the City of West Hollywood approving Demolition Permit 90-09 and a tandem parking request on an application of Helen Hobson McDowell to demolish a dwelling unit at 8920 Cynthia Street."

This item was pulled by Commissioner Gene Smith. He requested that the resolution mention that the design be consistent with the old Sherman District and the tandem parking is approved as incentive for maintaining the unit as a historic property.

3. August 2, 1990

He wants the "Action" on Development Permit 90-16, Demolition Permit 90-11, Negative Declaration 90-11 and Conditional Use Permit 90-10 to show detailed comments, "reduce size of lofts unless project qualifies under courtyard housing; more unified design; more compatibility with the great historical courtyard housing examples in West Hollywood; rooftop patios will be allowed as private open space for the project only if the building qualifies as a courtyard building; and lessen mix of styles under the courtyard housing ordinance.

Commissioner Litz wanted to correct the comments on Demolition Permit 90-09 (8920 Cynthia Street). It should read, "...Commissioner Litz asked if anyone wanted to reconsider the previous motion. Commissioner Gene Smith asked that the Commission reconsider."
