A. Commissioner Steve Smith read a motion for consideration by the Planning Commission relating to the Cedars Sinai Medical Center. The motion requests that Cedar Sinai Medical Center vote to build the AIDS facility, a move which will be considered by the City of West Hollywood as the act of a good neighbor.

All Commissioners voted to approve this request.

B. Commissioner Read mentioned that during the annual City Council/City Commissions planning meeting, parking was repeatedly cited as a key problem in the City and inquired about what is being done regarding this issue. The Director of Community Development explained that strategies, identification of areas for parking sites and various sources of funding are presently being investigated.

C. Commissioner Siegel inquired that in cases of appeal, what can the Commission do by way of giving some directions to Planning staff to avoid any misunderstanding and maintain the Commission's credibility. Commissioner Richmond talked about the Commission being represented before the City Council when a Planning Commission decision is on appeal. He inquired if there is a way that can be set so that under "Items From Staff" in each meeting, staff can orally report to the Commission what appeals or actions might have been filed on the previous two weeks. Additionally, Commissioner Gene Smith asked for a schedule of appeals that will be going before the City Council.

VIII. ITEMS FROM STAFF

- A. The Director of Community Development reminded the Commission about the Cultural Preservation study session on March 23, 1989.
- B. The Director also requested from the Policy Subcommittee a date to discuss the issues that was generated by the Harratt case and the substandard property.
