Action: To approve Minor Conditional Use Permit 87-09 subject to the conditions recommended by staff with the following changes: that sale of alcoholic beverages and a new dining room shall be eliminated; that the barrier between the room service kitchen and the library be reinstalled; that parties/special events on site be limited to 25 people unless a Temporary Use Permit has been issued by the City and that only one function shall be allowed at any one time and there must be a one-hour interval between scheduled functions; that no outdoor functions are allowed after 7:00 P.M. and no amplified music is allowed at any of the functions; that the applicant submit a Transportation Management Plan to the City to be reviewed and approved by the Transportation Commission; that the TMP shall include staff training program for hotel employees (which City staff shall attend), schedules for tour bus arrival and departures, and a system to keep guests inside the hotel until their bus/taxi arrives; that a car pooling program shall be required to specify how the goals outlined in the Settlement Agreement will be met and this TMP shall be reviewed by the City after six months for compliance; that the use of the rooftop tennis court after 9:00 P.M. be prohibited and the lights off at that time; and that the CUP will expire after five years with a one year review after the initial approval.
