I. CALL TO ORDER

II. ITEMS FROM CITIZENS

o Jeanne Dobrin, 9000 Cynthia, argued that this meeting was not correctly publicized and should be postponed to a later date. She distributed a memo to the Commissioners.

Staff responded that four methods of notification were conducted.

o Bud Kopps, 969 N. Larrabee, presented a written letter to the Commissioners.

III. PUBLIC HEARINGS

A. Variance Renewal Analysis - An analysis of options for dealing with expiring variances (continued from January 8, 1987).

The Commission agreed to limit individual speakers from the public to four (4) minutes.

- 1. Mark Winogrond presented the staff report and proposed two questions to the Commission:
 - a. Should variances have time limitations?; and
 - b. How should the City handle existing variances with time-limit expirations and violated conditions of approval?

Commissioner Fulton questioned the legal status of expired variances. Commissioner Richmond questioned the "non-conforming" status of expired variances. These are not non-conforming uses. Also, this time limit should not be challengeable in court because the applicants accepted the time-limit conditions.

2. Public Testimony

- o David Behr, 8127 W. Norton Avenue, 90046, presented written documentation and argued that the list of variance submitted to the Commission includes a number of errors.
- o Joel Edwards, 7321 Santa Monica Boulevard, 90046, read a prepared statement and presented such report to the Planning Commission (attached).
- o Joyce Hundal, 9002 Rangely Avenue, 90048, suggested that L.A. County issued variance were often C.U.P.'s and asked that input from the parking consultant be included in any discussion of existing variances.
- o Ethel Shapiro, 328 Westbourne, requested that existing time limits be retained.
- o Jeanne Dobrin, 9000 Cynthia, 90069, read a prepared statement from Cynthia Grace, Attorney at Law and distributed such to the Commissioners and requested strict enforcement of L.A. County issued variances (attached).

The Commission entered into a lengthy discussion and directed staff to explore and update specific cases and to design a process to allow for the review of active cases, identify problems, and mitigate these problems over time.
