chapters where there seems to be general agreement and then on to land use policies, and finally the land use map.

He also asked staff to find out about getting a podium to future Commission meetings.

- B. Commissioner Weinberger stated that the in-lieu fee revisions are being bounced back. The fee schedule should be presented to the City Council separately. Regarding the draft letter about the historic survey, as long as the changes which have been made are acceptable to the City Attorney, it would be acceptable to him. He also asked staff for a copy of the residential design guidelines. He stated that projects coming before the Commission have not been meeting the intent of the guidelines.
- C. Commissioner Smith was curious as to how other cities write historic preservation ordinances. He urged that a letter be sent to realtors who represent properties for sale to inform them of the survey.

- B. Jeanne Dobrin commented that some speakers were not given adequate time, and that staff should be directed to obtain a stopwatch or other adequate time-measuring device; she also urged that a city attorney be present at Planning Commission hearings.
