B. Commercial Revitalization
Debbie Potter, Economic Development Manager, and Jim
Shirey, Commercial Rehabilitation Specialist, presented
a report on West Hollywood's Revitalization Project/
Commercial Revitalization Program along Santa Monica
Boulevard.

### Public Comments:

- 1. Budd Kops, 969 N. Larrabee St., expressed conerns regarding the program eligibility requirements, security devices included in the program, and rehabilitation in the Western portion of the City.
- 2. Jeanne Dobrin, 9000 Cynthia St., expressed concerns about the compliance of the mortuary building's blank wall to the ordinance. She was also concerned about the colors of the project and the provision of street lighting in front of each store to provide "defensible space" for pedestrians.
- C. Discussion by Commissioners:
  The Commissioners discussed issues of targeting particular blocks or areas within the rehabilitation area, of the effect of absentee ownership on project, of linking design improvements to other economic programs, and the importance of a pedestrian atmosphere. Commissioners commended Jim Shirey and the Economic Development Division for their work.
