## Request for Proposals (RFP) for Consultant Services for a Rail Integration Study

The City of West Hollywood ("City") invites qualified firms or teams to respond to a Request for Proposals (RFP) to develop a Rail Integration Study.

The Rail Integration Study will include technical analyses and public outreach to ensure that future rail service is integrated thoughtfully into the West Hollywood Community while providing early input on design considerations relevant to upcoming environmental analysis and design work to be carried out by the Los Angeles County Metropolitan Transportation Authority (Metro) on the Northern Extension of the Crenshaw/LAX Line. Key areas of analysis include assessing the tradeoffs of potential station and portal locations, identifying first and last mile gaps and opportunities, evaluating potential tenant and business protection strategies, developing design standards to futureproof transit investments and protect the public interest, and other time-sensitive analyses. This work is intended to inform upcoming environmental analysis and design work to be carried out by Metro as well as future phases of City-led analysis and advocacy.

The City plans to enter into an agreement with the selected firm(s) based on negotiated scope of work and fee. Fees include all travel costs, materials, and printing costs associated with the project.
