ACTION: Support the Public Works Department's recommendation to replace the existing worn and faded colored stamped asphalt crosswalks on Santa Monica Boulevard with State of California/Caltrans standardized high-visibility continental crosswalk markings that are already in use at all other intersections on Santa Monica Boulevard, except at Santa Monica Boulevard/San Vicente Boulevard until staff returns with more data on the effectiveness of the rainbow crosswalks.
