#### 4. PUBLIC COMMENT:

NICOLE PAYTON, WEST HOLLYWOOD, presented as a member of the Women's Advisory Board and informed everyone that March is Women's History Month and encouraged everyone to visit the City website to view upcoming events. She also shared that she is the Executive Director of External Relations at the Luskin School of Public Affairs and offered to be a resource to the City on sustainability projects.

#### 5. COMMISSIONER COMMENTS:

The Commissioners spoke about the success of the Hart Park Improvements community outreach pop-up events.

Commissioner Karliss complemented the Arts & Cultural Affairs Commission for a wonderful Winters Sounds Concert Series. He spoke about the Rosewood Roundabout located at Rosewood and Westmount and Inquired what the plans are for that site.

Commissioner Polachek complemented staff for their hard work on maintaining the Santa Monica Blvd sidewalks clean.

Vice Chair Sunnanon thanked staff for installing the Big Belly trash receptacles with foot pedals.

Chair Block reminded everyone that the Green City Awards program is live and accepting applications.

#### 8. NEW BUSINESS

#### A. PROHIBITION OF SMOKING IN PUBLIC PARKS AND PARKLETS

SUBJECT: The Commission will discuss the proposed amendments to the West Hollywood Municipal Code prohibiting smoking in public parks and parklets and consider making a recommendation to City Council to adopt.

Danny Rivas and Daniel Mick introduced the subject and provided a presentation.

Commissioner Isaacs spoke in support of the proposed amendments.

Commissioner Polachek inquired about the cost of the citation. She also asked if there will be signage posted advising the public of the prohibition.

Commissioner Stapleton asked for clarification on where someone could stand and smoke near a park. He recommended having a 25ft buffer around parks and parklets to prevent smoke from drifting in.

Commissioner Karliss expressed concern with smoking occurring at the parklets that are nearby bars and asked if the parklet permittee's will be held liable if the smoking does not stop.

Commissioner Torres recommended doing a campaign about the prohibition to help disseminate information to the public. She spoke in favor of having signage advising the public of the prohibition of smoking.

Vice Chair Sunnanon inquired about the turnaround time for implementation of the proposed amendments. He asked clarifying questions regarding areas near the park that would be permissible to smoke.

Chair Block inquired about the methods of enforcement. He recommended including the Code Compliance contact information on the signage. Block made a recommendation to develop a plan for smokers to have a place to dispose of their cigarette butts.

ACTION: Provide commissioner comments to City Council as stated this evening to include considering placement of ashtrays for cigarette butt disposal.
