 - c. All Commissioners are able to place a nomination, and each nomination must receive a second in order to be considered by the Commission with a roll call vote.
 - d. The Chair announces that nominations are closed and requests a roll call vote.
 - e. Staff conducts the roll call vote. Each Commissioner is only able to vote yes on one name placed into nomination.
 - f. The nomination who receives the majority of yes votes is selected as the Green City Award recipient.
