9. <u>UNFINISHED BUSINESS</u>

A. CERTIFIED WILDLIFE HABITATS

SUBJECT: The Commission will consider public park locations for the City to pursue Certified Wildlife Habitat.

Helen Collins provided a presentation on the subject.

Commissioner Karliss spoke in favor of having the Certified Wildlife Habitat at Havenhurst Park and Formosa Park.

Commissioner Stapleton inquired if the public would be excluded from being in the Certified Habitat Areas. Ms. Collins stated that the public would not be excluded from those areas, however, if necessary, a small fence may be installed to protect the area from being damaged.

Vice Chair Sunnanon spoke in favor of the program and suggested having an educational component for the local schools.

Ms. Collins shared that there will be an educational component as well as a campaign to promote the program.

MIKE CARTER, CITY OF WEST HOLLYWOOD, spoke about Monarch Butterfly sanctuary gardens and encouraged the City to consider promoting them.

DANNY ROMAN, CITY OF WEST HOLLYWOOD, spoke about Monarch Butterfly sanctuary gardens and getting certified.

STEPHANIE HARKER, CITY OF WEST HOLLYWOOD, spoke about the Nature Conservancy and how to get certified. She spoke in favor of the Certified Wildlife Habitat program being presented.

ACTION: Accept staff recommendation with an addition to look at expanding the program to all parks in the future.

Motion by Commissioner Torres, Seconded by Commissioners Karliss, and approved unanimously.

B. FY19-20 CAPITAL IMPROVEMENT PROGRAM (CIP) PRESENTATION

SUBJECT: The Commission received an update on the Facilities and Field Services Division's CIP projects for FY19-20.

Helen Collins introduced the subject and provided a presentation.

Commissioner Torres inquired about the installation of the Solar Big Belly trash receptacles. She inquired about the City's plans for the vacant space adjacent to the Council Chambers.

Commissioner Karliss inquired about the City's rainbow crosswalk maintenance.

MICHAEL SWEENEY, CITY OF WEST HOLLYWOOD, inquired about rooftop solar installations in the City. He also spoke about electric vehicles for City use.

STEPHANIE HARKER, CITY OF WEST HOLLYWOOD, spoke about the projector screens at Council Chambers. She also spoke about the City's rainbow crosswalk.

ACTION: Receive and File.

Motion by Commissioner Polachek, Seconded by Commissioner Stapleton, and approved unanimously.

11. PUBLIC COMMENT:

STEPHANIE HARKER, CITY OF WEST HOLLYWOOD, spoke about the success of the Hart Park Improvement community outreach events that she attended. Ms. Harker suggested that the maintenance of the public restrooms should be increased to help stop the spread of Covid-19.

BRIAN FLORES, CITY OF WEST HOLLYWOOD, expressed concerns with

the licensing process for medical dispensaries.

Helen Collins spoke about the rooftop solar buildings in the City. She provided an update on the City's plans to purchase staff electric trucks. Collins provided an update on the closed caption screens at Council Chambers. She also provided an update on the current maintenance schedule of the City public restrooms.

The Commissioners thanked the public for their comments and feedback.

Commissioner Polachek provided an update on the Pet Memorial Ad Hoc Committee meeting.
