D. Public Comment:

Sepi Shyne, City of West Hollywood, congratulated the Board on their work they did with the Women's Leadership Conference which as a great success and thanked for their service. Sepi also shared a newly created group that she and nine other residents have co organized to help neighbors in need during COVID-19. Facebook page called WeHo Neighbors Helping Neighbors. Invited the Board to sign up and to share information with others to sign-up and volunteer. Congratulated Boardmembers Jenner Deal and Angela de Silva on being elected Vice Chair, and Chair and thanked them for their participation on the Facebook Live for Women's Equality Day.

5. UNFINISHED BUSINESS:

A. Women's Equality Day 2020: 19th Amendment Centennial Celebration

Larissa Fooks, Community Events Coordinator, updated the Board on plans for the City's annual commemoration of Women's Equality Day on August 30th highlighting the 100th anniversary of 19th Amendment to the United States Constitution. Thanked Vice-Chair de Silva, who helped put together a virtual exhibitor space promoting the19th Centennial the Conference. This event will be recorded and shared with the public, currently 200 attendees registered.

B. Covid-19 Related Updates and Community Support

Bonnie Smith, Public Safety Supervisor, provided information about how domestic violence issues since the Covid-19 pandemic and its impact within communities. She spoke about programs such as Project Safe Haven is a collaboration of the Mayor's Office and the Mayor's Fund for Los Angeles to secure safe housing for up to 900 survivors of domestic abuse during this difficult time and the 'Behind Closed Doors' public safety campaign to encourage residents to report violence in homes, particularly while they remain under stay-at-home orders. She also reported that restraining orders can be obtained by email, WebEx, fax, and phone and suggested that the Board might consider.

Staff shared that City Park's recreation spaces are available for public use by optional reservation. Reservations are available at Plummer Park in the Vista Lawn and Fuller Lawn areas and at West Hollywood Park in the Great Lawn area. Reservations must be made at least 24 hours in advance.
