5. NEW BUSINESS:

A. Covid-19 Related Updates and Community Support

Strategic Initiatives Manager, Corri Planck, presented an update on all the City services that are available to West Hollywood residents and community members

Boardmembers shared the following feedback and concerns:

- Board Member Eyres shared that domestic abuse hotline was difficult to find on the city website. Suggested that the information should be a little more obvious and easier to find on the Coronavirus website information page.
- Board Member Sutton brought up concern regarding mental health and having space for people to share their emotions and potentially get counseling during this difficult time.
- Board Member Bleich express how difficult it has been for her, and that if more support around mental health for people going through a hard time during COVID-19 pandemic.
- Board Member Payton shared with the board that at UCLA Luskin School of Public Affairs holds a City contract in which the social welfare students are providing mental health services for city workers.
- Board Member Moore inquired if we had any data how many women reached out for various services, and has the City noticed a gap where people aren't reaching out and maybe they should.

B. City of West Hollywood Women's Leadership Conference

Community Events Coordinator, Larissa Fooks provided an update on the City of West Hollywood Women's Leadership Conference. The event will be held August 18 through the 26th.

C. Annual Board Chair and Vice Chair Elections

Nominations for Chair opened by Chair Lubey. Vice Chair Deal and Board Member Eyres were nominated. Vice Chair Deal was elected Chair by a vote of 8-1. Vice Chair Deal nominated Board Member de Silva. Board Member de Silva was elected Vice Chair by acclimation.

A. Women's Equality Day 2020: 19th Amendment Centennial Celebration

The Board received an update on the City's annual commemoration of Women's Equality Day on August 30th highlighting the 100th anniversary of 19th Amendment to the United States Constitution. Board Members recorded video clips that will be compiled by Boardmember de Silva and presented at the next council meeting in honor of the 19th Amendment Centennial Celebration.

B. National Women's History Month Celebration 2020

Board discussed City's annual commemoration of National Women's History Month held during the month of March.

C. Board Workplan Review

Community Events Coordinator, Larissa Fooks reported that the City's in-person events for the rest of the year will be cancelled due to COVID 19 pandemic which will affect their workplan. At upcoming meetings, the Board will review and adjust the work plan accordingly.

7. LEGISLATION & ADVOCACY:

A. Legislative and Advocacy Updates on WAB Prioritized Issues:

1.Ratification of the Equal Rights Amendment Staff wanted to acknowledge the ratification that occurred in January. Lawsuits have been filed and it's anticipated it's going to go to the Supreme Court.

Board Member Eyres shared that there was a constitutional amendment that was passed by the state, so it could move on to the ballot in November. Which is about reversing a decision, a proposition that passed a while ago saying the state cannot do affirmative action and Equal Opportunity Programs say they have this rule that forbid that, and which stands on the books today.

Chair Lubey shared that she would like city and our board take a little bit more of a strong stance on the Cares Act. She encouraged the board to call our legislators and put some pressure on.

The initiative is under new leadership, final year of this initiative.
