- LOCATIONS:** 8941 SANTA MONICA BOULEVARD, West Hollywood, California
- REQUEST:** Applicant is requesting to combine two adjoining restaurant spaces (Bumsan – 8941 Santa Monica Boulevard) and (Café D’ Etoile – 8941 ½ Santa Monica Boulevard), into a new 2,718 square-foot nightclub/restaurant with food service, full alcohol, dance floor, and an outdoor patio. (“Stache”)
