He congratulated staff on the success of the Warrior Awards and encouraged everyone to reach out to their friends who may be struggling with substance use during the pandemic to check on their wellbeing.

Commissioner Meltzer appreciated being part of the Warrior Awards. She also congratulated Vice Chair Thomas on her appointment to the Planning Commission.

Commissioner Shandrick commented on the upcoming Rent Stabilization and Housing newsletter containing information on the rental assistance programs. He stated that the California Community Foundation will be focused on food insecurity in the next couple of months.

Vice Chair Thomas agreed with the importance of sharing social service resources with residents who are struggling during the pandemic. She commended Chair Davis on his leadership at the World AIDS Day event and thanked Commissioner Reback for calling out names of people who lost their lives to AIDS. Vice Chair Thomas was not sure of her transition date to the Planning Commission, but she thanked the Commission and staff for their incredible work.

Chair Davis congratulated Vice Chair Thomas on her appointment to the Planning Commission and thanked everyone who participated at the World AIDS Day event. He asked that the meeting be adjourned in memory of former Human Services Commissioner, Shirley Roberts.
