Proposers are encouraged to submit questions or requests for clarifications early in the process. Proposers that contact City personnel or City Council members after the City releases the RFP and throughout the evaluation period may have their proposals disqualified from consideration.

The deadline for submitting Proposals is <u>Thursday, June 17, 2021 no later than 4:00 P.M.</u> (Pacific Time). The Proposer shall submit one (1) digital copy of the submission on PlanetBids (<a href="https://www.planetbids.com/portal/portal.cfm?CompanyID=22761">https://www.planetbids.com/portal/portal.cfm?CompanyID=22761</a>) Proposals received after this time and date shall be disqualified. No oral, telephonic, faxed, emailed, or telegraphic proposals or modifications of proposals shall be considered.
