Draft Resolution No. HPC 21-152 A RESOLUTION OF THE HISTORIC PRESERVATION COMMISSION OF THE CITY OF WEST HOLLYWOOD RECOMMENDING THAT THE PLANNING COMMISSION AND CITY COUNCIL APPROVE A CERTIFICATE OF APPROPRIATENESS IN CONJUNCTION WITH NEW INTERNALLY LIT AND DIGITAL BILLBOARDS AT 9009 AND 9015 SUNSET BOULEVARD, WEST HOLLYWOOD, CALIFORNIA.

Action: Motion to approve, as amended Draft Resolution No. HPC 21-152, a Certificate of Appropriateness to permit proposed billboards at 9009 and 9015 Sunset Boulevard.

The HPC approved the Certificate of Appropriateness subject to the condition that the middle portion of the proposed sign have no wrapping and illuminated portion adjacent to the Rainbow pole mounted, can sign so that the new sign will not conflict with the existing character defining features. Motion by Commissioner Levin, second by Vice-Chair Dubin and passes unanimously 7/0 vote.
