

### **Sign Permit Application**

#### **INSTRUCTIONS**

The City of West Hollywood has developed a sign ordinance that regulates all signage in both commercial and residential zones. Most signs, including all permanent signs advertising a business, are subject to a sign permit issued by the Community Development Department. Table 3-12, attached to this packet, provides the basic and most frequently needed sign requirements. Further regulations may be found in the Zoning Ordinance, Chapter 19.34 - "Sign Standards".

The City has also adopted Sign Design Guidelines to guide applicants towards signage that is more appropriate to meet the City's urban design goals. In addition to the regulations, these guidelines should be considered when preparing your sign proposal.

**Please Note**: Cabinet (can) signs are not permitted for any sign in any zone. A cabinet sign is defined as "a sign that contains all the text and/or logo symbols within a single enclosed cabinet and may or may not be illuminated."
