# COUNCILMEMBER COMMENTS AND MEETING ATTENDANCE REPORTS:

Councilmember D'Amico thanked the City Council for understanding his need to be absent from the June 21<sup>st</sup> City Council meeting. He encouraged West Hollywood residents and visitors to West Hollywood to get vaccinated to ensure that West Hollywood remains a safe place to live and visit.

Councilmember Shyne requested that the City Manager provide an update on the updated LA County Health Order requiring masks indoors. She also asked him to clarify who enforces the City's mask mandates. She reported her attendance at the June 24<sup>th</sup> Homelessness Subcommittee meeting, marched in an unofficial march for Pride, attended Mickey's and Rocco's re-openings, as well as the July 15<sup>th</sup> West Hollywood Pride Subcommittee meeting. She mentioned Item 2.B. and noted that there is a typo for spelling "Goldman." Finally, she shared that 99% of people hospitalized for COVID-19 are unvaccinated compared to those who are vaccinated experiencing mild symptoms.

Councilmember Erickson agreed with Councilmember D'Amico's comments regarding vaccinations. He reported that he attended the Mickey's re-opening and the Black Pride event at Rocco's. He also attended the 3<sup>rd</sup> District Oversight Board and the Hearing Board AIDS Healthcare Foundation "Housing is a Human Right" panel regarding Hunger Issues. Finally, he wished former Councilmember John Heilman and Senior Advisory Boardmember Nadia Sutton a Happy Birthday.

Mayor Pro Tempore Meister reported that she attended SCAG CEHD Committee representing WSCCOG where the committee discussed SCAG's role in economic development. She also reported that she attended the Mickey's re-opening event, as well as the June 24<sup>th</sup> Homelessness Subcommittee meeting. She noted the cancellation of the July 22<sup>nd</sup> Homelessness Subcommittee meeting due to a scheduling conflict with Dr. Sherin, Director of Mental Health for Los Angeles County. Finally, she noted that she agrees with her colleagues encouraging everyone to get vaccinated.

Mayor Horvath also encouraged everyone to get vaccinated and reminded everyone about the free testing site at Plummer Park. She reported that she attended the National League of Cities Summer Leadership and Board meeting, Contract Cities E-Board Meeting, Homelessness Panel with Housing is a Human Right, the State of the City with the Chamber of Commerce, the Employee Appreciation Luncheon and former City Manager Paul Arevalo's Farewell. She shared that at the Wednesday, July 21 City Council meeting there will be another opportunity to wish Paul farewell. She reported that she attended the Mayor's for Guaranteed Income event. She also attended the Liability Trust Fund Claims Board and Oversight and the Sanitation District meeting. She thanked everyone who participated in the Walkabout on the Eastside. She provided information on the Gubernatorial Recall Election taking place on Tuesday, September 14. Fiesta Hall at Plummer Park will be a 4-day Vote Center beginning on Saturday, September 11. She provided important deadlines related to the election. She

announced that LA County of Mental Health announced a partnership with Breaking Binary to discuss issues affecting the community. Finally, she gave a special shoutout to Nick Wagman, who will be participating in the Tokyo Summer Olympics in Equestrian Dressage.

### **CITY MANAGER'S REPORT:**

City Manager Wilson provided an update on the LA County Health Order which went into effect on Sunday, July 18. He noted that the City is issuing mask citations through Code Compliance and providing education regarding the requirements. He encouraged people to visit <a href="www.vaccinatelacounty.com">www.vaccinatelacounty.com</a> for vaccine information. He reported that City Hall is scheduled to reopen to the public by appointment only on July 26 unless there is a significant change to the LA County Health Orders.

City Clerk Melissa Crowder provided an update to the Wednesday, July 21<sup>st</sup> City Council meeting. She noted that the meeting was originally scheduled to be conducted via a hybrid meeting format; however, due to the updated LA County Health Order it will be conducted via teleconference.

# 3. PUBLIC HEARINGS:

3.A. REQUEST TO PERMIT THE CONVERSION OF A STATIC ON-SITE ADVERTISING BILLBOARD TO A NEW DIGITAL OFF-SITE ADVERTISING BILLBOARD ON THE PROPERTY LOCATED AT 9157 SUNSET BOULEVARD [J. KEHO, J. ALKIRE, B. ECK, J. DAVIS]: SUBJECT: The City Council will consider the proposal is to convert an existing, one-sided static billboard located at 9157 Sunset Boulevard to a new, one-sided digital billboard for off-site advertising under the Sunset Boulevard Off-Site Signage Policy. The application requests are for the approval of a development agreement, a zoning map amendment, a sign permit, and a certificate of appropriateness.

City Clerk Crowder reported that this Item was noticed as required by law.

Senior Planner Bryan Eck provided background information as outlined in the staff report dated July 19, 2021. Staff is requesting that the conditions in Attachment C be modified for the unit of measure from lumens to candelas per meter squared as well as Condition 3.6 to require that any architectural lighting be shielded from view from the public right of way.

Councilmember Shyne inquired about the standard of brightness for digital billboards. She inquired if these standards apply to the operator logo. Senior Planner Eck responded to this inquiry noting that it the logo is fully dimmable.

Jeff Seymour of Seymour Consulting spoke on behalf of the applicant. He introduced Benjamin Anderson of Office Untitled who provided a presentation on the proposed billboard.

Mayor Horvath opened the public hearing, and the following speakers came forward.

LYNN RUSSELL, WEST HOLLYWOOD, spoke regarding a small change to the steel arms (armature) since the building is historic.

JAKE STEVENS, LOS ANGELES, spoke on behalf of Faring Capital in support of the billboard.

Councilmember D'Amico spoke regarding vacancy requirements. He noted that the ground floor space should not remain vacant beyond six months regardless of the additional funding to the City. He requested that the Development Agreement be amended to include language regarding vacancies and what will happen if the ground floor space is vacant beyond

six months. Senior Planner Bryan Eck responded to Councilmember D'Amico's comments noting that Section 4.5 of the Development Agreement.

Mayor Pro Tempore Meister commented on an email from Planning Commissioner Michael Lombardi and asked staff to address his inquiries regarding lighting. Mr. Eck mentioned after his presentation that the conditions addressed these inquiries. She expressed concern with the lack of discussion regarding the operator's logo at the Historic Preservation Commission meeting and the discussion at Planning Commission regarding no logo. Mr. Eck shared that the applicant requested that a logo be included with the billboard after the Commission meetings. He further shared that it complies with the Sunset Boulevard Arts and Advertising Program. She recommended that Section 6.2.1 "Minor Adjustment" require a Director's Hearing rather than approval by the City Manager. Finally, she inquired if the piping will be brushed metal, so it doesn't reflect and if there is lighting. Mr. Eck responded to this inquiry.

Mr. Eck shared the signage operational controls to ensure that new signs are good neighbors. He also responded to Councilmember D'Amico's concern regarding vacant storefronts in the building. Mr. Eck referred to Section 4.5 "Building Occupancy" in the Development Agreement addresses this. Councilmember D'Amico commented that this section doesn't entirely address the issue of vacant storefronts.

Mayor Horvath disclosed that she spoke with the applicant prior to the public hearing. She clarified that the billboard is not an official gateway sign since gateway signs are part of a different project. She commented on the height change of the billboard. She expressed concern with illumination of the support structure and requested a six-month review of it.

Mayor Pro Tempore Meister made a motion to approve the item as presented with a change to Section 6.2.1 "Minor Changes" shall be approved as part of a Director's Hearing in the Development Agreement and the change to Section 4.5. "Building Occupancy" in the Development Agreement. It was seconded by Councilmember D'Amico.

City Attorney Langer noted that it is always the City's goal that billboards don't support a commercial vacancy. She read the following change to Section 4.5 in the Development Agreement into the record:

"Notwithstanding the above if the space(s) facing Sunset Boulevard remain vacant for more than one year, the digital advertising shall be turned off until the spaces are occupied."

Mayor Horvath closed the public hearing.

Councilmember Erickson also inquired if City services will not be fully funded if the ordinance is passed. City Manager Wilson indicated that the budget was approved, and services funded.

Mayor Pro Tempore Meister inquired about overtime. She also inquired about the City enforcing the ordinance on a complaint-based basis. Community and Legislative Affairs Manager John Leonard responded to this inquiry. She also inquired about recall and retention, specifically with respects to the Standard Hotel. City Attorney Langer responded to this inquiry.

Mayor Horvath inquired if the ordinance directs cutting workers hours. Mr. Leonard responded to this inquiry. She also inquired if staff still has issues that need to be explored. Mr. Leonard responded to this inquiry.

> Councilmember Shyne provided a list of untruths that were disseminated by the Chamber of Commerce via mailers, emails, and phone calls throughout the community. She made the following motion based on the points that staff requested direction:

- Approve Personal Security Devices Option 1 in staff report operative date1/1/22
- Approve Right to Recall & Retention Option 1A and 1B in staff report – operative date 9/1/21
- Approve Right of Recall with the current Local Emergency 1 year following the lifting of the current local emergency.
- Approve Public Housekeeping Training Option 1 in staff report operative date 7/1/22
- Approve Workload Standard and Compensation language from Initial Draft Ordinance circulated in June (Section 5.128.030) and attached to the item – operative date 1/1/2022
- Addition the definition of Room Cleaning Proposed by Staff in the staff report
- Approve Overtime Consent Provisions in proposed ordinance (Attachment 1)
- Approve Waiver and Suppression Language in proposed ordinance (Attachment 1)
- Approve Remedies and Enforcement Option 1 in staff report (language in proposed ordinance (Attachment 1)

The Motion was seconded by Mayor Horvath.

Mayor Pro Tempore Meister disclosed that she spoke with the Hotel Council and Unite Here union representatives and workers. She spoke about the provisions of the ordinance that she supported, which included measures to protect hotel workers from violent or threatening conduct, right of hotel worker recall, hotel worker retention, and public housekeeper training. She asked what kind of workload compensation system the union hotels used. Staff did not have a response to this inquiry. She noted her preference for a credit-based system and her hope that hoteliers and the union could work together to find a compromise. She felt overtime pay should apply to overtime hours. She also questioned if seven days' notice for overtime was practical. Regarding the Public Housekeeping Training, she requested that the City Manager contract with three sources so that pricing would be competitive and timing needs could be met.

Mayor Horvath enumerated and clarified how the ordinance was brought forward, the direction to staff, and the outreach by the Councilmembers and staff. She mentioned the misinformation and the disconnects between what the hoteliers are saying versus hotel worker testimony. Finally, she commented that the intent of the ordinance is to create a wage and workload standard.

Councilmember Erickson commented that he wants to focus on facts and spoke about some of the articles written regarding the proposed ordinance. He shared that he believes the hotel workers who spoke here tonight, and that the ordinance enacted in Santa Monica is a comparable standard to follow.

The changes in the revised ordinance were shown on the screen and placed into the record for first reading.
