**Patrick Blood**, WEST HOLLYWOOD, spoke as the liaison from the Disabilities Advisory Board regarding the placement of e-bikes and scooters on sidewalks being a hazard to those with disabilities.

**Mojen Jenkins**, WEST HOLLYWOOD, introduced herself as the liaison from the Lesbian and Gay Advisory Board.

**David Eichman**, WEST HOLLYWOOD, spoke as the Senior Advisory Board Liaison regarding the possible need for pedestrian signage at points where pedestrians tend to cross where there are no crosswalks and the need for a No U-Turn sign at La Cienega Boulevard and Holloway Drive.

## 4. NEW BUSINESS:

# A. 8850 Sunset Boulevard Draft Environmental Impact Report Public Comment Period.

The Commission received a report from Doug Vu, ASLA, Senior Planner and Emily Wong of Gibson Transportation who prepared the Traffic Impact Study and provided feedback on the Draft Environmental Impact Report.

**Susan Milrod**, WEST HOLLYWOOD, commented that the building seemed too large and spoke about possible traffic impacts.

**Nick Shaffer**, WEST HOLLYWOOD, commented that there was too much overdevelopment happening and stated that Larrabee Street is too narrow to accommodate the traffic after the hotel is built.

**Todd M**., SANTA MONICA, suggested that Ride Share options stopped being treated as a positive alternative to parking needs, because they actually have a bad negative on traffic and added that Harrat Street will need much improvement after the hotel is built.

**David Goldschmid**, WEST HOLLYWOOD, stated that Larrabee Street may be too narrow to accommodate the traffic after the hotel is built.

**Don Tinling**, WEST HOLLYWOOD, commented that there is not enough parking planned for the proposed hotel and asked if there was a Ride Share Zone planned somewhere on the property.

The Commission explained their experience with the transit services available at the site.

The Commission pointed out that there is Permit Parking on Larrabee. They also discussed pedestrian crossing at Sunset and Harratt. Additionally, they discussed commercial vehicles on Larrabee Street.

Mr. Vu indicated that staff is taking the questions and comments, and the City's responses will become part of the Draft EIR.

The Commission suggested including information on construction time, Electric Vehicle Charging Stations, as well as Scooter and E-Bike charging. They also commented on the use of greenery at the site. October 20, 2021

The Commission urged the City to study, understand and present the options of egress on Larrabee Street. They also discussed the various challenges with traffic flow at Sunset and Larrabee, specifically queuing and safety issues.

Commissioner Bowen disclosed that he lives within 500 feet of the project for the record.

The definition of FAR was defined by Mr. Vu as "floor area ratio" in response to an inquiry from Chair Williams.

Chair Williams thanked the public and her fellow Commissioners for providing comment on the DEIR.
