

ORDINANCE NO. 21-1171

AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD AMENDING THE WEST HOLLYWOOD MUNICIPAL CODE TO ADD CHAPTER 9.13 (BUSINESS ESTABLISHMENTS – POSTING AND TRAINING REQUIREMENTS) OF TITLE 9 (PUBLIC PEACE AND SAFETY) TO REQUIRE POSTING OF SIGNAGE AND TRAINING RELATED TO PATRON SAFETY AND AWARENESS AT BUSINESS ESTABLISHMENTS THAT SERVE ALCOHOL FOR ON-SITE CONSUMPTION; AMENDING TITLE 5 FOR REFERENCE; AND AMENDING CHAPTER 1.08 (GENERAL PENALTY PROVISIONS) TO MAKE VIOLATIONS SUBJECT TO ADMINISTRATIVE PENALTIES.
