**NOTICE IS HEREBY GIVEN** that the West Hollywood Planning Commission will hold a Public Hearing to consider the following item:

- LOCATIONS:** 8920 SUNSET BOULEVARD, West Hollywood, California;
- REQUEST:** This item was officially continued from the Planning Commission meetings on Thursday, February 17, 2022 and Thursday, March 3, 2022. Request to amend the previously approved Arts Club Project including: 1) reconfiguration of subterranean garage and reduction of total parking from 351 to 279 spaces; 2) change in use from private member guestrooms to office space on the fifth floor; 3) reduction of The Arts Club membership cap from 6,745 to 5,500 members; and 4) minor building design refinements including configuration of outdoor terraces, elimination of the private rooftop pool, and other minor floor plan revisions.
