## NOTICE – REQUEST FOR QUALIFICATIONS (RFQ) DESIGN-BUILD SERVICES for

STORIES: THE AIDS MONUMENT

PUBLIC NOTICE IS HEREBY GIVEN that the City of West Hollywood as Agency, invites qualifying proposers ("Proposer") to submit a Pre-Qualification Package ("PQP"), through this Request for Qualifications ("RFQ") process, electronically only at <a href="https://www.planetbids.com/portal/portal.cfm?CompanyID=22761">https://www.planetbids.com/portal/portal.cfm?CompanyID=22761</a> for STORIES: The AIDS Monument (the "Project" or "Monument") no later than the hour of 1:00PM, Friday, April 15, 2022.

The Agency plans to contract with a single entity for both design and construction ("Design- Build Entity" or "DBE") of an outdoor art monument commemorating the devastation and impact of HIV/AIDS worldwide. The scope of work for the Project includes all disciplines necessary to complete the remaining design and perform the construction of the Monument, including, without limitation, all on-site and off-site work. This Notice is to solicit PQPs from design-build teams (including contractors and design professionals) based on the RFQ requirements and shortlisted design-build teams will be invited to submit a proposal in response to a Request for Proposals ("RFP") as the second part of the selection process.

Copies of the RFQ and associated documents are available for free from the <a href="https://www.planetbids.com/portal/portal.cfm?CompanyID=22761">https://www.planetbids.com/portal/portal.cfm?CompanyID=22761</a> The Agency hereby affirmatively ensures that minority business enterprises will be afforded full opportunity to submit a PQP in response to this notice and will not be discriminated against on the basis of race, color, national origin, ancestry, gender, religion, sexual orientation, or handicap in any consideration leading to the award of contract.

The selection of the DBE will be in accordance with the design-build procurement requirements of Public Contract Code section 22160 et seq. and the selected DBE will be required to follow, among other things, the Public Contract Code, the Labor Code, and the following provisions.

Pursuant to Labor Code sections 1725.5 and 1771.1, all contractors and subcontractors that wish to bid on, be listed in a bid proposal, or enter into a contract to perform public work must be registered with the Department of Industrial Relations ("DIR"). No proposal in response to the RFP will be accepted nor any contract entered into without proof of the selected DBE's and their subcontractors' current registration with the Department of Industrial Relations to perform public work. If awarded a contract, the DBE, and its subcontractors, of any tier, shall

maintain active registration with the Department of Industrial Relations for the duration of the Project.

Any contract entered into pursuant to the RFP will incorporate the provisions of the State Labor Code. Pursuant to the provisions of Section 1773.2 of the Labor Code of the State of California, the minimum prevailing rate of per diem wages for each craft, classification, or type of work person needed to execute the contract shall be those determined by the DIR of the State of California, which are on file at the City Hall, City of West Hollywood, 8300 Santa Monica Boulevard, West Hollywood, California 90069, and are available to any interested party on request. It shall be mandatory upon the DBE to whom the contract is awarded, and upon any subcontractors, to comply with all Labor Code provisions, which include but are not limited to the payment of not less than the said specified prevailing wage rates to all workers employed by them in the execution of the contract, employment of apprentices, hours of labor and debarment of contractors and subcontractors. This Project is subject to compliance monitoring and enforcement by the DIR.

The City of West Hollywood's Living Wage Ordinance shall be followed when applicable. The Living Wage Ordinance may be found at West Hollywood Municipal Code: Chapter 3.20 Living Wage Requirements for Service Contracts.

Attention is directed to the provisions of Section 1777.5 (Chapter 1411, Statutes of 1968) and 1777.5 of the Labor Code concerning the employment of apprentices by the Contractor or any such subcontractor under him. Affirmative action to ensure against discrimination in employment practices on the basis of race, color, national origin, ancestry, sex, religion, sexual orientation, or handicap will also be required.

The selected DBE will be required to take affirmative action to ensure against discrimination in employment practices on the basis of race, color, national origin, ancestry, gender, religion, sexual orientation, or handicap.

The selected DBE offers and agrees to assign to the awarding body all rights, title, and interest in, and to, all causes of action it may have under Section 4 of the Clayton Act (15 U.S.C. Section 15), or under the Cartwright Act (Chapter 2 [commencing with Section 16700] of Part 2 of Division 7 of the Business and Professions Code), arising from purchases of goods, services, or materials pursuant to the public works contract or the subcontract. This assignment shall be made and become effective at the time the awarding body tenders final payment to the DBE, without further acknowledgement by the parties.

**Interest in More than One Submission:** No Proposer shall be allowed to make, submit, or be interested in more than one SOQ. However, a contractor, design professional, firm, corporation, or other entity that has submitted a sub-proposal to a Proposer is not thereby disqualified from submitting a sub-proposal to other Proposers.

## **Performance and Payment Bonds:**

The selected DBE will be required to furnish insurance certificates and endorsements as described in the RFP, a bid bond for 10% of the project total, a performance bond in the amount of one hundred percent (100%) of the contract price, and a payment (material

and labor) bond in the amount of one hundred percent (100%) of the contract price on the forms provided, and in the manner described in the RFP. Only bonds executed by an admitted surety insurer, as defined in Code of Civil Procedure Section 995.120, shall be accepted. The surety must be a California-admitted surety with a current A.M. Best's rating no less than A: VII and satisfactory to the Agency.

Requests for Clarification (RFI's) and Questions: All questions and requests for information shall be submitted electronically at http://www.weho.org/city-hall/city-departments/public-works/public-works-bids under the above stated project. Any questions addressing the interpretation or clarification of the Statement of qualifications Forms or the Statement of qualifications Documents must be submitted no later than Monday, April 11, 2022, at 1:00 p.m. through the City's electronic submission process. Following this deadline, no questions regarding the statement of qualifications packet will be accepted.

**License Requirements:** Pursuant to Section 7028.15 of the Business and Professions Code and Section 3300 of the Public Contract Code, the selected DBE must possess proper licenses for performance of the Project. The selected DBE shall possess, at a minimum the following valid California contractor license to perform the work: **Class A or B.**
